### Chaplain's Corner March 2022

\*\*\*\*\*

The last couple of years have reinforced in me some observations I have made through the years regarding humankind. Namely, many people are uncomfortable with other people's opinions if they differ from their own. This is especially important when we consider faith and religions. Which, I suppose, is where I come in.

If I were to ask us to identify Jesus Christ, how would we do so? Would



any of us be able to describe him in such detail that another person could recognize Jesus if he were to suddenly materialize on a street we

lived on? This is important because he has promised to return as described in several instances in the Gospel of Luke. He warns his followers to distinguish between those who will come bearing his name but they won't be the real him in Chapter 21 that you may read for yourselves.

I want to focus on Chapter 24 (one of my favorite texts) which I deem more relevant to us today for it occurs after Jesus has been tried, killed, buried and resurrected and reappearance on earth to those who knew him yet had trouble recognizing him.

Now on the first day of the week, very early in the morning, they, and certain other women with them, came to the tomb bringing the spices they had prepared. But they found the stone rolled away from the tomb. Then they went in and did not find the body of the Lord Jesus. And it happened, as they were greatly perplexed about this, that behold, two men stood by them in shining garments. Then, as they were afraid and bowed their faces to the earth, they said to them, "Why do you seek the living among the dead? He is not here but is risen! Remember how He spoke to you when He was still in Galilee, saying, 'The Son of Man must be delivered into the hands of sinful men, and be crucified, and the third day rise again."

And they remembered His words. Then they returned from the tomb and told all these things to the eleven and all the rest. It was Mary Magdalene, Joanna, Mary the mother of James, and the other women with them, who told these things to the apostles. And their words seemed to them like idle tales, and they did not believe them. But Peter arose and ran to the tomb, and stooping down, he saw the linen cloths lying by themselves; and he departed, marveling to himself at what had nappened.

Now behold, two of them traveled that same day to a village called Emmaus, seven miles from Jerusalem. And they talked together of all these things which had happened. So it was, while they conversed and reasoned, that Jesus Himself drew near and went with them. But their eyes were restrained so that they did not know Him.

And He said to them, "What kind of conversation is

this that you have with one another as you walk and are sad?"

Then the one whose name was Cleopas answered and said to Him, "Are You the only stranger in Jerusalem, and have You not known the things which happened there in these days?"

And He said to them, "What things?"

So, they said to Him, "The things concerning Jesus of Nazareth, who was a Prophet mighty in deed and word before God and all the people, and how the chief priests and our rulers delivered Him to be condemned to death and crucified Him. But we were hoping that it was He who was going to redeem Israel. Indeed, besides all this, today is the third day since these things happened. Yes, and certain women of our company, who arrived at the tomb early, astonished us. When they did not find His body, they came saying that they had also seen a vision of angels who said He was alive. And certain of those who were with us went to the tomb and found it just as the women had said, but Him they did not see."

Then He said to them, "O foolish ones, and slow of heart to believe in all that the prophets have spoken!
Ought not the Christ to have suffered these things

and to enter into His glory?" And beginning at Moses and all the Prophets, He expounded to them in all the Scriptures the things concerning Himself.

Then they drew near the village where they were going, and He indicated that He would have gone farther. But they constrained Him, saying, "Abide with us, for it is toward evening, and the day is far spent." And He went in to stay with them.

Now it came to pass, as He sat at the table with them, that He took bread, blessed and broke it, and gave it to them. Then their eyes were opened, and they knew Him, and He vanished from their sight.

And they said to one another, "Did not our heart burn within us while He talked with us on the road, and while He opened the Scriptures to us?" So they rose that very hour and returned to Jerusalem and found the eleven and those who were with them gathered together, saying, "The Lord is risen indeed, and has appeared to Simon!" And they told about the things that had happened on the road and how He was known to them in the breaking of bread.

Jesus Appears to His Disciples

Now, as they said these

things, Jesus Himself stood in the midst of them and said to them, "Peace to you."

The text continues with the proofs and words that Jesus used to identify himself and confirm who he was. And that is my point. The Living Word is confirmed through the written word, and authenticated through his actions.

Let our hearts burn within us as we come to believe what we know him to be.

Peace be upon you all.

**New Members:** James (Jim) Robinett (Air Force) just joined. Bo Brown (Navy) will join tonight.

**Motion** to approve the January Minutes postponed because the *Dispatch* has not been published yet.

### **Officer Reports:**

President's Report: The Pig Roast is set for 28 August, during the National Leadership Conference. Flag Day, which we are doing with other organizations this year, is set for 12 June. The Recognition Dinner will be held at 1800 on 23 April at the UAW Hall. Please send your food ideas to Wendy Hibbitts. We have applied for the \$500 gift card from Meijer's again. If we get it, we will use it for the Dawn Farm Thanksgiving Dinner. We have everything we need for the apartment we are furnishing in Dexter, thanks to the great work of Joe Palazzolo, who came in under budget.

Treasurer's Report: Berry Bourne. Reports were emailed to the Board. Reports are also available to members and others via email. on request. Non-restricted funds received \$1,700 in donations and \$1,200 in interest. We paid out \$745 of the \$1,500 authorized for the Dexter apartment. The Christmas program has produced over \$22,000 in donations this year. We also presented a \$5,000 check to Kate Melcher at Fisher House. The Finance Committee is studving where to move our bank accounts and how best to invest our surplus cash. No questions.

**AVVA Report:** Driscoll. Please see report in the *Dispatch*. We are doing our \$5 wrist bracelet fundraiser for Fisher House. Girls' State returned our excess payment. Lois Perrault Memorial Fund is over \$3,000. We are still

collecting trial-size toiletry items for Fisher House. The no-bake bake sale for Fisher House is in progress.

Committee Reports:

Merchandise: We have new inventory coming in. We will have a small sale set up for the Open House here on 26 March.

**Washtenaw County Council of Veterans:** The Council's February meeting will be here on the 21<sup>th</sup>, sponsored by VVA 310.

Michigan State Council: Luker. We should consider our proposal to amend National's Constitution to open membership as dead-onarrival at National. It turns out that the litigation with the IRS was not just about AVVA members. The IRS has an illegal rule limiting 501(c) (19) organizations to veterans who served during a Congressionally declared "wartime." For various reasons. VVA National will not spend any more money fighting with the IRS over its illegal rule. Therefore, we should consider turning our attention to what we can do locally, with Local Veteran's Alliance.

Memorial Maintenance: Merritt. We have new crews set up for maintenance this year, but there is not much to do until the weather breaks. We are still trying to get the building built, but we don't have an estimate for when that will happen.

**Membership:** We lost member Mike Samar recently and gained Jim Robinett, so our number remains at 210 members.

**Newsletter:** Jane Kinzinger. The Dispatch is late this month because Paulo needed extra time to defend his dissertation. He was successful, earning Doctor of Education (EdD) degree.

LTCCSKMC: Kinzinger. The Christmas donors really came through this year. Thank you to the Chapter members who donated generously this year. This year's letter included a flyer from Fisher House. That might explain the increase in donations. As a result, the Committee is considering making another donation as soon as matching funds are offered again.

**Specialist 4 Earl Thomas Hoag** was born on March 9, 1948 in Detroit, Michigan to Mr. Robert

Alpena Junior

College and Cleary College. Earl worked for United Air Lines as a flight food handler at Detroit Metropolitan Airport.

Specialist 4 Hoag entered the Army on April 20, 1968 completing his Basic Training at Fort Ord, California and Advanced Training at Fort Polk, Louisianna. He began his tour of duty in Thua Thien Province, South Vietnam on August 19, 1968 serving as an infantryman with B Company, 2nd Battalion, 502nd Infantry, 101st Airborne Division. Earl was killed when his patrol was ambushed and he sustained multiple fragmentation wounds on March 8, 1969. He died just one day before his 21st birthday.

Earl Thomas Hoag is survived by his parents and three brothers. He lived 20 years, 11 months and 29 days. He is resting in Grand Lawn Cemetery in Detroit, Michigan. Earl's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His

name also appears on the Vietnam Memorial in Washington, DC on Panel 30W Line 076.



**Private First Class Frank Leslie Keck** was born on June 1, 1946.
Frank attended Saline High School



in Saline,
Michigan
for six
years,
returning
to
Kalkaska,
Michigan
after the
death of
his father.
He would
have

been in the 1964 graduating class in Saline where he played varsity basketball. He worked in construction before entering the Army in June of 1968.

Private First Class Keck began his tour in Tay Ninh Province, South Vietnam, on December 22, 1968, serving as an infantryman with C Company, 4th Battalion, 23rd Infantry, 25th Infantry Division. He died as a result of enemy small-arms fire on March 29, 1969.

Frank Leslie Keck is survived by his wife and son, his mother, and one brother. He lived 22 years, 9 months and 28 days. Frank's name is listed on the Vietnam Memorial in Ypsilanti Township under Saline. His name also appears on the Vietnam Memorial in Washington, DC on Panel 28W Line 082.



Private First Class Lavern Michael Lamey was born on November 7, 1949 to Mr. and Mrs. Ralph



J. Lamey of Milan, Michigan. Lavern is a 1967 graduate of Lincoln Consolidated High School. He entered the Army on

July 18, 1967 receiving his Basic Training at Fort Knox, Kentucky. He completed his Advanced Training at Fort Polk, Louisiana.

Private First Class Lamey began his tour of duty in Dak To, Kontum Province, South Vietnam on December 16, 1968 serving as a Grader Operator with the 15th Engineering Company, 299th Engineering Battalion, 937th Engineering Group. Lavern was killed by enemy mortar fire on March 5, 1969.

Lavern Michael Lamey is survived by his parents, his wife, a brother and two sisters. He lived 19 years, 3 months and 28 days. He is resting in Marble Park Cemetery in Milan, Michigan. Lavern's name is listed on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 30W Line 047.

According to First Lieutenant McLemore in a letter to Mrs. Shambaugh, "On March 6, 1968, while Gregory was participating in a search and destroy mission with Company D, 1st Battalion, 502nd Infantry, he was struck by an enemy bullet and instantly killed." The Bronze Star Medal was posthumously presented to Mrs. Shambaugh.

Gregory is survived by his parents and his wife. He is resting in Arborcrest Cemetery in Ann Arbor, Michigan. Gregory is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 43E Line 034.

### Care Package— Thank You!

On November 2021, we had
our annual pre-Christmas Care
Package event at the VFW Post
423. The mailing addresses we
received came from the Michigan
West Point Parents Association.

Our November Care Package mailing was the first time we have had no troops in a war zone. We began sending Care Packages in 2004 (4,414 total packages to date).

We still have many military personnel stationed all over the world, so we still had addresses to send packages to. Those military personnel were going to be away from home for the Christmas holidays. As we Veterans know, they could use the morale boost of a Care Package from caring people whom they had never met. The following is from a card we received dated 12-17-21.

"Dear Vietnam Veterans, I just wanted to write and thank you so much for sending a giant Christmas care package down here to Honduras! I know you all know better than most that it's tough to be away from home, especially during the Holidays – so the Chaplain and I will make sure it gets to a soldier who needs some cheer. Thanks again from Honduras! Reilly Kissinger"

We should be very proud of our long-term effort to morale boost tens of thousands of military personnel serving overseas. When we began, we swore to send packages until our troops came home from war. Well, we did it. And

our packages were always quite large, and each one was shared with many in their group.

Early on, I remember doing packing in our living room. The earliest packers included Doc and Sandy Martinez, Roy and Bonnie Hall, Lois and George Perrault, Sandy and Gene Morley, and others. George and Roy, especially, did the yeoman's work over the years. In time, we moved the packing to the VFW Post 423 and opened it up to the public to help. Those patriotic folks, like the Hittes, would bring items, donate funds, help with packing, and join in a potluck meal afterwards.

Early on we received mailing addresses from folks in the community who knew of someone serving overseas, and the addresses came! As the years went on--and with less personnel in the war zone--we would receive mailing addresses from the Michigan West Point Parents Association. Our contact, Lou Steenstra, always came through for us with a list to send packages.

For fundraising, we would hold "Support Our Troops" rallies and sell dog tags for \$5 each to many people. We have had great supporters who donated to most all our packings after that. I would be remiss if I did not mention our member Elmer White, who for most of our last ten years of packing would offer to match up to \$500 at each packing to be used for postage. He personally donated at least \$10,000 of the estimated \$80,000 we spent on just postage to mail all the 4,414 Care Packages.

We mailed some interesting things.

We mailed baseball gloves and balls. I remember sending some golf clubs and even a set of iron horseshoes. But I believe the most important items were over 5,000 Harley Davidson shirts, bandanas, and other items. We had a special connection to a local source, who would contact us when her office had collected boxes of sample shirts sent to them to be approved to be used in Harley stores across the U.S.

In 2005, our family went to Fort Hood. Texas for a 1st Cavalry Reunion celebration. While our son, John Alva, was being given a tour through a Bradley vehicle, I was talking to one of the troopers in charge of the vehicle. They had returned from Iraq a couple months earlier. Looking at this huge vehicle, I thought I recognized the unit number on the vehicle as one we may have sent packages. Out of curiosity, I asked the trooper if they ever received anything really special while deployed. He thought and said, yes, we did. One time we received a large box of Harley t-shirts. He said that meant so much to him that, to that day while back home, he wore his Harley shirt to bed each night. The emotion of that fact about knocked me down. That was the greatest confirmation I could receive that what we were doing really made a difference for our patriots serving overseas.

We made a difference for so many. And I would like to thank everyone who ever came out and helped in anyway. TEAM, TEAM, TEAM! Great job.

- c. Must fill out the We/Email Roster Access Form and submit it to the AVVA National Membership Committee chair after each election to be approved to receive the Chapter roster. (See FORMS/Membership forms at the AVVA website)
- 3. Must lead the Chapter within the guidelines of AVVA's policies and bylaws.
- 4. Shall be the voting delegate for their Chapter at AVVA state meetings. Should the Chapter representative be unable to attend the state meeting, he/she may appoint an alternate.
- 5. Shall be the voting delegate for their Chapter at AVVA national conventions. Should the Chapter representative be unable to attend the national convention, he/she may appoint an alternate.
