Call to Order by President Harrison at 1900 hrs.

Pledge of Allegiance

Roll Call: A quorum was established. Welcome Home Everyone! One person attended via Zoom.

New Members: None.

Motion to approve the August Minutes by Merritt/Bull. Approved.

President's Report:

- Many things going on, mostly being done by the Memorial Committee. They will report on all of that later.
- At the board meeting we voted to create a strategic plan that would take effect on 1 March 2021.

Treasurer's Report: Bourne. \$470 receipts this month. We had lots of large transactions related to the shed. We have spent \$9,600 on the shed so far. We will submit a request for reimbursement from the Ann Arbor Community Fund Foundation through Ypsilanti Township. There is a shed funding project underway. Some checks are being sent directly to the Chapter and some donations are being made through the GoFundMe website.

AVVA Report: Their report is printed in the Dispatch. Food Pantry: No report.

Merchandise Report: Harrison: On 26 September, Ann Arbor Arms is going to have an open house from 0900 to 1500. Volunteers are needed. We will begin to set up at

0700.

Washtenaw County Council of

Veterans: Harrison. I attended the meeting. We talked about some scholarship money being available for children.

Michigan State Council: Luker. The next meeting is set for 27 September in Holly.

Memorial Maintenance: Merritt The lawnmower blew its crankshaft seal. The mower is not worth repairing. Enough donations have been received to pay for a new riding lawnmower. Doan Construction did a great job doing concrete for the Kettles bench. the backside of the Memorial and for the kneeling soldier. They are standing by to do the foundation for the shed when the time comes. DTE announced that they will install a transformer during the week of 14 September. Al Walk found a contractor who gave us a great price for doing the underground plumbing to get water to the shed. Al is donating his labor to do all the plumbing work inside the shed.

The committee has also organized the now annual Veterans Suicide Prevention Demonstration which places 22 crosses every day of the month of September. The committee is also working with Fowlerville Baptist Church and Veterans Refuge Network to build replacement crosses.

Website: McCrumb. The website is working and has had 216,000 hits.

Membership: The official number is now 207.

Newsletter: Pereira. No report. Healthcare: Wilson. Although VA says you can now get your flu shot, you still can't get it at the VA. You must show your VA card at most pharmacies to get a free flu shot. Remember to ask for the senior flue shot, if you qualify.

VAAAHS: Kinzinger. Nothing will be going on until they open up. They are starting to let a few volunteers return to work.

Old Business: None New Business:

Motion by Kinzinger, seconded by Rivers to sell the dog tag machine to the Honor Guard for \$750. Motion failed.

Motion by Kinzinger, seconded by Throneberry to give the dog tag machine to the Honor Guard. Approved.

Good of the Order:

Wilson: Veterans Voice of America is an organization started by younger VVA employees (inspired by President John Rowan) that will operate the Household Goods program. President Rowan is convinced that younger veterans do not want to join VVA.

Wilson: The grand opening of the Fisher House has not been scheduled. Fisher House Ann Arbor does not want us to donate dinners anymore, even though the house is being used regularly.

McCrumb: John K and I visited Mrs. Kettles. She'll be 90 on 3 November. She looked good and was glad to have us visit.

Chief: Happy 73rd birthday to the Air Force

Bull: The organizations that use the VFW 423 hall are having another open house on 24 October. There will be a couple service officers there to help with claims and at least one Navigator from Community Mental Health. The hours for this one are 10 to 1700 because it is getting dark earlier.

Bull: American Legion Post 46 is hosting a drive-through food drive

here on 3 October from 0900 to 1400. We are accepting toiletries, such as the sample sized ones you might get from Kroger or a dollar store, as well as canned or boxed food.

Wilson: I soon will have some cloth face masks for sale for \$2 that say, "Agent Orange Next Generation."

Draper: There are two dumpsters near the front gate that were donated by a local area church. I cleaned and painted them. They are a place for people to put flags that need to be retired. The local boy scout troop said they would conduct flag retirement ceremonies as needed.

Kinzinger: WACU is hosting a packing party at 1000 on 12 September. The packages will go to local veterans. Then, on 1 November, there will be another packing party. This one will begin at 1500 and will be the usual VVA Christmas packing party. This time, WACU will fund it, including the postage.

Bull: Based on feedback I've received, the "Cans for Troops" program has been changed to benefit the Fisher House Ann Arbor. We've donated \$400 of gift cards to them, so far.

Throneberry: Veterans Radio will hold a live "There I was" program via telephone on 20 September from 1700 to 1800. This time, the theme will be "Why I joined the military." The show will be available for podcast by 1700 on Monday.

Bourne: I still have several food cards from Holidays.

Bourne: When we passed the hat, we collected \$440 toward buying the new lawnmower.

Hall: I'd like to give a shout out

to American Legion Post 46 for buying steak dinners for all the patients at the Ann Arbor VA for POW-MIA day.

The Mission of the Memorial Maintenance Committee is to encourage respect and reverence for Washtenaw County's fallen Vietnam Veterans through the following means:

- Maintain and improve the Memorial and the surrounding grounds
- Ensure that services and other events are conducted with respect and without damage to the Memorial or grounds

<u>The Goal:</u> The Memorial and grounds will perpetually be clean, well-kept and serene.

The Measure of Success: The grounds will be inspected by at least one Chapter Officer on an unannounced basis more than 15 times a year. The inspections will reveal that there is no trash, the lawn and other vegetation are well maintained, and that physical property is in good repair. The grounds will also be inspected within two days after any significant event.

An annual maintenance plan is developed that shows when routine maintenance will be performed and by whom. The plan will include both paid and volunteer duties. The plan will be implemented as planned except when interrupted by weather or illness

In addition, comments from the public, especially those from the families of the people named on the wall, will be favorable. Resources Provided: The Chapter will maintain a restricted account for funding Memorial Maintenance and Improvement. The Chapter will contribute general funds to the Memorial Maintenance Restricted Fund on an annual basis in an amount determined after the Finance Committee and the Memorial Maintenance Committee discuss the Memorial Committee's tactical plan for the following fiscal vear.

The funding provided shall be sufficient to maintain necessary equipment including a riding mower, a trailer, a self-propelled walk-behind mower, a weed whip, a leaf blower, a generator and accessories.

Authority Granted: The Chair of the Memorial Maintenance Committee is authorized to sign contracts for Memorial maintenance and improvement as outlined in the Committee's annual tactical plan as budgeted. The chair is also allowed to disperse funds from the Memorial Maintenance Restricted account for budgeted expenses necessary to accomplish the above described mission.

The Chair of the Memorial Maintenance Committee has supervisory authority over all volunteer individuals and organizations that support Memorial Maintenance. The Memorial Maintenance Committee makes all final

decisions concerning the Memorial, its use, landscaping and so forth within budget parameters. Limitations Imposed: No plaque or other commemorative device may be placed for any business nor for any person who is not a Vietnam Era Veteran or AVVA Member or Friend. Nor may such a device be placed for a living person.



Courtesy for Township Employees is Essential: A Request

An incident occurred at the Memorial that makes it necessary to remind readers of the importance our Chapter places on our relationship with Ypsilanti Township and its employees. The bottom line is that, if there is ever anything you don't like about the Memorial, what goes on at the Memorial, or if there is anything about the Memorial that distresses you in any way, there are only two people in the world you need to talk to about it: Al Merritt or Jon Luker. They are in contact with anybody else who has anything to do with how things work at the Memorial. If the problem needs to be fixed, Al and Jon know whom to contact to get that problem solved. Ypsilanti Township has bent over backwards to accommodate VVA 310 and the Washtenaw County

Vietnam Veterans Memorial. Even though we have occupied a bit more land than the lease calls for, and even though we have increased the Township's workload-both administratively and by asking more of their grounds crews than originally expected—the Township continues to treat us and our Memorial as a priority. They honor us and our fallen with respect, with prompt responses, and with praise for our work at the Memorial. The very least we can do in return is to make sure we treat the Township employees with the courtesy and respect they deserve.

One person who claimed to be a Township resident recently complained to one of the grounds crew managers about the pile of brush Team One placed out by the curb near the Memorial grounds. It is one thing to complain, but the resident acted as if the grounds crew was an indentured servant with nothing better to do than to respond instantly to the resident's complaint. That interaction jeopardized the great working relationship the Memorial Maintenance Committee has with the Township and its employees. It is okay to be disappointed or upset about something happening at the Memorial, but it is best if you address the correct people with your issue rather than letting your emotions lead you to take it out on an innocent party.

We were the problem in that case, not the Township. If anyone who reads this ever has a problem with anything about the Memorial, the Township is not to blame. The problem belongs to Al Merritt, who is in charge of the Memorial Maintenance Committee, or to

Jon Luker, who most likely caused the problem. Speak to us about your issue and let us figure out how to deal with it. We will get the job done without jeopardizing our relationship with one of the Chapter's best long-term partners. You may text or phone Al Merritt or Jon Luker or email them. Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 28E Line 069.

Corporal Eugene Ravn Suarez was born on December 21, 1946 to Mr. Rafael P. and Mrs. Helen Suarez of Ann Arbor, Michigan. Eugene is a 1966 graduate of Ann Arbor High School. He also had a paper route with the Ann Arbor Newspaper. He attended Washtenaw Community College in Ypsilanti, Michigan before entering the Army on October 4, 1967.

Corporal Suarez began his tour of duty in Quang Tin Province, South Vietnam on May 24, 1968 serving as an infantryman with D Company, 1st Battalion, 46th Infantry, 198th Infantry Brigade, Americal Division. Eugene died on October 1, 1968 as a result of enemy small arms fire. He was posthumously promoted to Corporal and received the Bronze Star Medal.

Eugene Ravn Suarez is survived by his mother, three brothers and six sisters. He lived 19 years, 9 months and 10 days. He is resting in Arborcreast Cemetery in Ann Arbor, Michigan. Eugene's name



is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington,

DC on Panel 42W Line 060.

Captain David Raymond Wagener was born on June 22, 1939 to Mr. and Mrs. Lawrence L. Wagener of Saline, Michigan. David is a 1957 graduate of Saline High School where he was an honor student, an out-standing athlete lettering in football, basketball and track. He also attended the University of Michigan prior to enlisting in the Air Force in 1959. He also attended the University of Delaware. David received his Basic Training at Lackland Air Force Base in San



Antonio, Texas and was commissioned a Second Lieutenant. He attended Aviation Cadet

Training at Harlingen Air Force Base in Texas. He received his pilot flying wings at Williams Air Base, Chandler, Arizona.

Captain Wagener began his tour of duty in Udorn, Thailand serving with the 602nd Fighter Squadron, 14th Air Commando Wing, 7th Air Force. According to a posting from a colleague, Ira Cooperman, "Dave Wagener was a friend and a brave 'Sandy' pilot. While stationed at Udorn RTAFB in 1966, he flew 'cover' for helicopter missions attempting to rescue downed American pilots in Laos, as well as to support friendly forces on the ground in Laos. It was from one of those missions that he did not return." On October 20, 1966, Captain Wagener was shot down and killed about 20 miles north of the DMZ in Quang Binh Province.

His body was not recovered. David Raymond Wagener finally came home on December 5, 1997 when his remains were discovered. David is survived by his wife, mother and two brothers. He lived 27 years, 3 months and 28 days. He is resting in Tahoma National Cemetery in Kent, Washington, Section 6, Site 595. David's name is listed on the Vietnam Memorial in Ypsilanti Township in two locations. The first location is on the bench in front of the Memorial listed with two other men listed as MIA. The second location is on the Vietnam Memorial under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 11E Line 092.

Specialist 4 Charles Wesley Bird was born on January 16, 1943 in

Belle, West Virginia. He is a 1961 graduate of Dupont High School in Belle, West Virginia. Charles worked for Ford Motor Company at the Rawsonville Plant and was married three months before entering the Army on October 24, 1966. He lived in Ypsilanti residing with his wife's parents until his induction.

Specialist 4 Bird began his tour of duty in Binh Duong Province, South Vietnam on April 17, 1967



serving with D Company, 4th Battalion, 9th Infantry, 25th Infantry Division as an infantryman. Charles died as a result of enemy small arms fire on October 14, 1967. He was posthumously awarded the Bronze Star Medal and Purple Heart. Charles Wesley Bird is survived by his wife and a brother and serveral sisters. He lived for 24 years, 8 months and 28 days. He is resting in Montgomery Memorial Park in Fayette, West Virginia. His name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. Charles' name also appears on the Vietnam Memorial in Washington, DC on Panel 27E Line 106.

Captain Carl Robert Arvin was born on January 19, 1943 in Ypsilanti, Michigan to Mr. and Mrs. Carl J. Arvin. C. Robert Arvin graduated from Ypsilanti High School in 1961 where he excelled as a straight-"A" student, and was named as Valedictorian. Captain Arvin excelled in athletics during High School playing on the varsity football and wrestling teams. In 1961, he wrestled his way to a State high school wrestling championship. During his junior year of High School, Carl earned a High School Honors Science Institute scholarship of \$100. He was also Student Council President, and President of his class of 1961. Carl Robert Arvin was accepted to the United



States Military Academy at West Point in 1961 as a member of the Corps of Cadets of 1965 where he continued to achieve academic and

athletic recognition. In recognition of his achievements, C. Robert Arvin was appointed as the highest ranking cadet in the Corps' chain of command with the title of First Captain and Brigade Commander. Carl Arvin received his commission as a Second Lieutenant in the United States Army in 1965 graduating as the top cadet of 2,770 in the Corps of Cadets First Lieutenant Arvin began his tour in Thua Thien Province, South Vietnam on May 29, 1967 serving with Advisory Team 162, 7th ARVN Airborne Battalion, Military Assistance Command Vietnam (MACV). According to a note on the Virtual Wall, "First Lieutenant Arvin received two awards of the Silver Star Medal, the first for an action on September 5, 1967 when the 7th Vietnamese Airborne Battalion...came under intense mortar and small arms fire. Though wounded, Arvin disregarded the fierce fire and was leading his element forward to engage the enemy when his radio operator was also wounded. Arvin dragged the soldier to safety and, undaunted by the perilous circumstances, returned to direct repeated helicopter aunship strikes. He refused his own medical evacuation until the objective was secure and the mission complete.

Rodger Edson Terwilliger is survived by his wife, a son, a daughter, his father and his stepmother, a brother, six step-brothers, and four step-sisters. He lived 24 years, 8 months and 26 days. He is resting in Arlington National Cemetery in Arlington, Virginia, Section 13, Site 16284. Rodger's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 11E Line 078.

Legislation Action! Please take action and support Tester/
Harder Amendment in the FY2021

National Defense Authorization

Act.

September 23, 2020 The House and Senate Armed Services committee will soon meet to reconcile legislative differences in the House (H.R. 6395) and Senate (S.4049) version of the FY 2021 National Defense Authorization Act (NDAA) recently passed in both chambers. Vietnam Veterans of America joins Congressman Josh Harder (D-10th-CA) in his push to conferees--the Honorable Adam Smith, Chairman, Armed Services Committee; Mac Thornberry, Ranking member, House Armed Services Committee; Senator James Inhofe, Chairman, Senate Armed Services Committee; and Jack Reed, Ranking Member, Senate Armed Services Committee--to retain the bipartisan Harder/Tester amendment that would add three diseases. bladder cancer, hypothyroidism, and Parkinsonism as serviceconnected conditions.

Each of these diseases has met the scientific threshold of the National Academies of Sciences, Engineering, and Medicine, to be credibly linked to Agent Orange. What remains is the addition of these conditions to the list of Agent Orange-presumptive diseases.

Our Vietnam veterans should not have to wait any longer for the recognition they deserve and the benefits they are owed.
