I enjoy seeing the pictures from Mars and the rising earth from the moon taken from the Chinese rover to see all the darkness around our planet, and yet from our planet there is so much light out in space. Creation is marvelous, with so much to discover, even after all these years.

I want to talk about the preeminence of Christ in creation as recorded in Hebrews 1:

### Honoring June Anniversaries on the Wall

Second Lieutenant Philip Matt
Crane II was born on January 29,
1947 to Mrs. Howard P. Gragg
and the late Philip M. Crane
of Ypsilanti. Philip played the
accordion when he was very
small. He played Little League
Baseball. Philip is a 1965 graduate
of Ypsilanti High School where
he played on the varsity tennis
team, was a member of the varsity
debate team, and a member of the
National Honor Society. He worked
all during high school and college



at the A&P Store. He went on to attend the University of Michigan until he enlisted in the Army on February 1, 1967. He completed Officer Candidate School at Fort Benning, Georgia.

Second Lieutenant Crane began his tour in Vinh Long Province, South Vietnam on May 14, 1968 serving as a Tactical Intelligence Staff Officer on Advisory Team 52, Headquarters, Military Assistance Command Vietnam (MACV). Lieutenant Crane was flying in a helicopter as a special observer when a flare ignited inside the aircraft causing him to fall from the aircraft on June 26, 1968. He was "In-Country" for one month and 11 days.

Philip Matt Crane II is survived by his mother, his wife, and a sister. He lived 21 years, 4 months and 27 days. He is resting in Crestwood Memorial Gardens in Flint, Michigan. Philip's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 54W Line 002.

### Major Frank Rudolph Maki

was born on March 13, 1928 in Rudyard, Michigan to Mr. Victor and Mrs. Lemple Ann Maki. Frank graduated from Rudyard High School before enlisting in the Army in 1946 where he completed his Basic Training at Fort Lee, Virginia. He took part in the Berlin Airlift serving at the Rhein Main Air Base as an Air Ground Liaison NCO. He returned from Germany and spent some time as a civilian before returning to the Army in 1950 where he served with the 7th Infantry Division in Korea as a rifle and weapons squad leader. Sergeant Maki accepted a reserve



commission as a Second Lieutenant while serving in the Korean War. He continued to serve in the Regular Army as an NCO,

as he was promoted as a reserve officer. Since Korea, Frank served with the 821st Engineer Aviation Battalion at Fort Leonard Wood, Missouri then serving with the 820th Engineer Aviation Battalion at Michigan State University as a military science instructor. According to the Battalion History of the Army ROTC Battalion at Eastern Michigan University, "in 1961, he taught ROTC at Eastern Michigan University for four years, where he led the rifle team to the championship and served as an advisor to Arm of Honor Fraternity. During this time, he accepted his promotion to Captain even though he was rated number one on the list to be promoted to Sergeant Major. He then served as a Company Commander at Fort McClellan where his troops would earn four consecutive Best Company awards." Major Maki began his tour of duty in Quang Tri Province,

duty in Quang Tri Province,
South Vietnam on May 7, 1971
serving as an Advisor, Advisor
Team 3, Headquarters, Military
Assistance Command Vietnam
(MACV) Advisors, MACV. Captain
Maki was killed in action at Fire
Support Base Fuller in Quang
Tri Province while coordinating
medical aid to wounded soldiers
on June 22, 1971 during his third
tour in Vietnam. He was then
posthumously promoted to Major.

Award of The Silver Star for gallantry in action: Captain Maki distinguished himself by gallantry in action on 20 - 22 June 1971 while serving as Senior Advisor to the 1st Battalion, 2d Regiment, 1st Infantry Division, Army of the Republic of Vietnam at Fire Support Base Fuller in Quang Tri Province. Captain Maki heroically participated in the defenses of Fire Support Base Fuller by accompanying and assisting his Vietnamese counterpart against the North Vietnamese Army thrust. After more than two continuous days of intensive direct and indirect fire and ground attacks, the NVA managed to breech the defenses. Captain Maki then directed many tactical air strikes and aerial rocket artillery against the enemy. During this time he continued to reappraise the tactical situation, adjust supporting fires and coordinate medical aid to the wounded Vietnamese soldiers. Though he had been sixty hours without rest, he continued to assist his counterparts up until the moment he was mortally wounded by an enemy artillery round. His extraordinary example of leadership and valiant courage radiated throughout the Fire Support Base and inspired the Vietnamese to repulse the enemy attack. Captain Maki's conspicuous gallantry in action was in keeping with the highest traditions of the United States Army and reflects great credit upon himself and the military service. (As written in Major Maki's Award of the Silver Star announcement, by LTC August G. Seifert) Frank Rudolph Maki is survived by his wife, son, two daughters,

his father, two sisters and two brothers. He lived 43 years, 3 months and 9 days. He is resting in Highland Cemetery in Ypsilanti, Michigan. Frank's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 03W Line 086.

Corporal Richard Mark O'Neal was born on May 22, 1948 to Mr. and Mrs. William O'Neal of Ann Arbor, Michigan. Richard is a 1966 graduate of Ann Arbor High School. He entered the Marine



Corps on July 6, 1966 going through Marine Corps Boot Camp at Marine Corps Recruit Depot, San Diego, California.

He received his Advanced Infantry Training at Camp Pendleton, California before being stationed with the Headquarters and Service Company, First Marine Brigade in Hawaii

Corporal O'Neal began his tour of duty in Quang Tri Province, South Vietnam on May 31, 1968 serving as a rifleman with E Company, 2nd Battalion, 3rd Marines, 3rd Marine Division, III Marine Amphibious Forces. Richard died on July 26, 1968 of head injuries suffered in a truck accident.

Richard Mark O'Neal is survived by his parents, a brother and

four sisters. He lived 20 years, 2 months and 4 days.

According to a posting by Richard's nephew, "I never had the chance to meet you but I just wanted to say that I love you and I appreciate everything that you did for our country. Your brother,..., named me in honor of you. I hold your name in high regard and I continue to work harder every day to be the best person I can be. Every day I wake up is a chance to become better than I was the day before. I have been fortunate enough to marry the woman of my dreams and, thanks to the people that matter to me the most. I have been able to work hard enough to receive my B.A. in Journalism-Public Relations from SHSU. Thank you to everyone on here that has posted something, it was moving to read events that happened in his life. Uncle Richard, I will continue to hold our name in the highest honor. I love you and I will meet you some day." Richard is resting in United Memorial Gardens in Plymouth, Michigan. Richard's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 50W Line 015.

H. Neil Stehle was born on March 30, 1945 to Mr. and Mrs. Herbert H. Stehle in Ann Arbor. Neil is a 1963 graduate of Ann Arbor High School where he was on the gymnastics team. He attended Eastern Michigan University majoring in psychology prior to entering the United States Army on April 29, 1967.



Neil is listed under Ann Arbor on the Ypsilanti Township Vietnam Memorial and is located on Panel 58W Line 027 on the Vietnam Memorial in Washington, DC.

President's Report:

also made available to members and others via email on request. We received \$3,500 for Pig Roast donations, which qualifies us to receive the \$1,000 matching fund gift as well.

**AVVA Report:** The report is printed in the Dispatch.

**Committee Reports:** 

**Merchandise:** Harrison. No activity, but I do have challenge coins with me tonight.

Washtenaw County Council of Veterans: Harrison. We learned that there is now \$70,000,000.00 in the Veterans Trust Fund, so make sure that veterans who have needs know about that and apply for it.

Michigan State Council: Luker.

DAV is no longer doing VSO work. VVA hired most of their employees and is picking up where DAV left off. The State Council is also getting ready for the Region 5 preconference to be held in Columbus, Ohio 24 – 26 September.

Memorial Maintenance: Merritt.
Lawns crews are out and doing good work. The changes we made to drainage are showing now in that the boxwood bushes have grown 3 inches since this spring. The building project is underway. Diversified Excavation installed water, did some initial grading, dug footers for the building and the trench for the electricity and then regraded and reseeded the area. Doan Construction expects to pour the foundation in the first week of June.

**Website:** McCrumb. Almost 8,000 hits this month, so we are up to 277,483 hits. 3,000 people hit the Memorial page on Google Maps, 5 of whom clicked through to the website.

Membership: McCrumb. We are at

209 again.

Newsletter: Pereira. No report. Healthcare: Wilson. You may now take your family members with you to the VA when you get your vaccine and they will be vaccinated also. If you haven't been vaccinated, wear your d\*\*n mask. But, if you have been fully vaccinated for at least two weeks, you don't need to wear a mask anywhere anymore. Office workers will be allowed to return to work in a couple weeks.

**CSKMC:** (Formerly VAAAHS, Formerly AAVAMC) Kinzinger. The evening meal on the Fourth of July is being upgraded to steak. The meal is being paid for out of the Support for Hospitalized Veterans Fund.

Old Business: None Good of the Order:

**Dunlap:** There will be a three-hour pepper spray class here at 1000 on 12 June 2021 for people who are 18 years old or older. The fee is \$10. The VFW will provide food. There will be a CPR class on 25 July 2021.

**Draper:** As you may have seen in our April Dispatch, several of our members were honored for the volunteer work at the VA hospital. The highest awards were received by our Chapter members.

**Merritt:** Breakfast tomorrow will be at 0900 at Holiday's Restaurant in Ann Arbor.

Bourne: Not many of the veterans who are food insecure are able to get to Holiday's Restaurant to take advantage of the gift cards that were donated to us for that purpose. Therefore, we have decided to sell the gift cards at face value and use the funds from those sales to purchase gift cards from places like Meijer's and

Kroger's that can be more easily used by the intended beneficiaries of the gifts.

Kinzinger: Our guys are being remembered. Jane and I went to Larry Prososki's funeral at Holly. While we were there, we visited Dave Hizer's grave and then went to the columbarium to see the final resting place of Pete Belaire, and then his brother, David Belaire. Wilson: I was working with a doctor who is researching disease among Vietnam veteran children. Her research has shown that there are many more cases of ADHD and Autism in veteran families than there are in civilian families. As you may remember, there are 91,000 specimens in storage at Wurtsmith Air Force Base that came from the Operation Ranch Hand research. Linda Swartz must find a new place for them because the Air Force is no longer authorized to do non-war activities. I will be doing an Agent Orange presentation up north once people are permitted to

**Wilson:** Need to do early registrations for the convention if we can. Rubber chicken for the Saturday night banquet. Delegates should apply soon.

**St. Antoine:** There are several lawsuits going against California Air Force bases for cancer caused by PFOS and other water pollutants.

Bull: The VA hospital is already using its new official name. There will be a public name change ceremony in June, probably.
Bull: We and Team Red, White & Blue are cohosting a Flag Day event here at the post on 13 June. We will hold an old-fashioned picnic like the churches used to do. There is not a set itinerary. It is

# Legislation Action! H.R. 2568 Vietnam Veterans Liver Fluke Cancer Study Act

The last movement of this bill was on May 29, 2019. This bill was referred to the Subcommittee of Disability Assistance and Memorial Affairs by the Committee on Veterans' Affairs. As of today, Thursday, December 17, 2020, there are 17 co-sponsors to this bill. Tim Walberg (R-I7) is the only Michigan US Congressman to co-sign this bill. If you live in another congressional district, please contact your representative to have him or her co-sign this bill. Our AVVA 310 has widows whose Veteran husbands suffered and died from liver cancer. Please consider writing your US Congressional Representative to support this bill in honor and memory of them.

"Highest need for gift cards are for groceries: Kroger and Sam's Club (they accept Walmart gift cards, too). That's where we shop the most. The larger the quantities, too (each trip runs us about \$250-300), and we go at least twice a week. It takes a lot of time to process multiple \$25 gift cards for one trip (if that makes sense just from a donation tracking system)."
