Thompson was born on December 2, 1942 in Ann Arbor, Michigan to Mr. James B. and Mrs. Mildred Thompson. Stanley is a graduate of Ann Arbor High School and the Alexandra School of Cosmetology. He was also a former Washtenaw County Junior Deputy. He entered the Army and spent two years in Germany before re-enlisting in

an infantryman with 3rd Platoon, A Company, 1st Battalion, 16th Infantry, 1st Infantry Division. Stanley was killed on February 4, 1966 when he stepped on a Viet Cong land mine.

Stanley James Thompson is survived by his parents and wife. He lived 23 years 2 months and 2 days. Stanley's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 05E Line 001.

Warrant Officer James Eugene Kirby was born on October 27, 1941 to Mr. and Mrs. Grover P. Kirby of Ann Arbor, Michigan. James graduated from Ann Arbor



High School in 1958. James Kirby was a professional serviceman serving in the

Marine Corps for four years before enlisting in the Army in November of 1964. He attended jump school at Fort Benning, Georgia, and later attended Air Force Flight school at Fort Rucker, Alabama. Warrant Officer Kirby was assigned to the 203rd Aviation Company, 223rd Aviation Battalion, 17th Aviation Group of the First Aviation Brigade in Phu Hiep, Binh Dinh Province, South Vietnam.

Warrant Officer James Eugene Kirby began his tour of duty in Vietnam on November 2, 1968. James was flying a mission on February 11, 1969 when his aircraft was hit by enemy antiaircraft fire and the aircraft crashed killing James instantly.

James Eugene Kirby is survived by his parents, his wife, a son, and a daughter. He lived 27 years, 3 months and 14 days. James is resting in the Bethlehem Cemetery in Ann Arbor, Michigan. His name is listed on the Vietnam Memorial located at the Ypsilanti Township Hall under Ann Arbor. He is also listed on the Vietnam Memorial in Washington, DC on Panel 32W Line 013.

Captain Clark Newell Woodworth,

Jr. was born on September 19, 1934 in Ann Arbor, Michigan to Clark and Rose Woodworth, Sr. Clark graduated from Ann Arbor High School in 1952, and from Michigan State University in 1958. Captain Woodworth, Jr. began his career in the United States Army on January 2, 1959. He was assigned as the Drone Section Commander in the 503rd Aviation Company of the Third Armored Division, United States Army, Europe (Germany). He was based at Fliegerhorst Airfield, Hanau, Germany from September, 1961 to January, 1964.



He also commanded C Company Seventh Battalion, Third Training Brigade at Fort Gordon,

Georgia from December, 1964 to December of 1965.

Clark began his tour in Vietnam on January 3, 1966 serving as an advisor with the 10th ARVN Infantry Division, Advisory Team 87, HQ, MACV Advisors, MACV. Captain Clark Newell Woodworth, Jr. was killed on February 28, 1966 as a result of multiple fragmentation wounds in Binh Thuy Province, South Vietnam. Captain Woodworth, Jr. is survived by his wife and a sister. He lived 31 years, 5 months and 9 days. A memorial fund was set up in Clark's honor. The Woodworth Library is a 40,000-volume library located inside the entrance at Fort Gordon, Georgia, which is named in honor of Clark. There is a portrait of Clark that is hung in the library that was painted by Norman

Clark Newell Woodworth, Jr. is at rest in Arlington National Cemetery. His name is located under Ann Arbor on the Vietnam Memorial located at the Ypsilanti Township Hall, and is located on the Vietnam Memorial in Washington, DC on Panel 05E Line 092.

Specialist 4 Larry Adams was born on May 3, 1949 in Detroit, Michigan to Foster Adams and Merlin



King. Larry attended Ypsilanti High School prior to enlisting in the Army on January 29, 1967. Specialist

4 Adams went through Basic Training at Fort Leonard Wood before attending a ten-week long helicopter maintenance course at Fort Rucker, Alabama. Larry started his tour of duty in An Kye, Thua Thien Province, South Vietnam on August 13, 1967. He served with B Company, 229th Assault Helicopter Battalion, 11th Aviation Group, 1st Cavalry Division. Although trained as a helicopter mechanic, Larry was flying a mission on a helicopter as a gunner when the aircraft was struck by enemy small arms fire killing him instantly on February 23, 1968.

Specialist 4 Larry Adams lived 18 years, 9 months and 20 days. He left behind his parents, a brother and a sister. Larry is resting in United Memorial Gardens in Plymouth, Michigan. His name is located on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 40E Line 072.

Private Stoddard began his tour of duty in Bien Hoa Province, South Vietnam serving as an Armor Crewman with Headquarters and Headquarters Company, 1st Battalion, 5th Infantry, 25th Infantry Division. Keith was killed on February 1, 1971 due to the accidental self-detonation of an

as the school's outstanding scholarathlete. He played football.

basketball and track. He attended Eastern Michigan University in Ypsilanti, Michigan prior to entering the Army in 1966.

Specialist 5 Fulton began his tour of duty in Tay Ninh Province, South Vietnam on February 28, 1967 serving as a Medical Noncommissioned Officer with B Company, 588th Engineering Battalion, 79th Engineering Group, 20th Engineering Brigade. Kenneth was on a convoy in the Mekong Delta when it was ambushed. He was killed on February 15, 1968 as a result of multiple fragmentation wounds.

According to a posting from Jack

Engle, "a plea for help was made and SP5 Fulton answered the call without concern for himself, as he always had for the last year. 'Doc' did not have to be in the position he was in: he could and should have been in the rear until the area was secured. He had less than 15 days before going back to his earthly home, but yet chose to be where his 'duty' was. Instead, he went to his heavenly home. Going to the aid of a fellow soldier in need, he was killed in action." Kenneth Lige Fulton is survived by his wife, a daughter and his parents. He lived 21 years, 5 months and 8 days. He is resting in Michigan Memorial Park in Flat Rock, Michigan. Kenneth's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 39E Line 047.

Private First Class Ronald Lee Koch was born on December 17, 1947 in Ann Arbor, Michigan to Mr. and Mrs. Wilbert Koch of Lima Township, Michigan. Ronald is a 1966 graduate of Chelsea High School in Chelsea, Michigan. He worked for the Larowe Feed



Company in Chelsea before entering the Army on March 2, 1967. He received his Basic Training at Fort Knox, Kentucky and Advanced

Training at Fort Polk, Louisianna. Private First Class Koch began his tour of duty in Binh Duong Province, South Vietnam on July 27, 1967 serving as an infantryman with A Company, 1st Battalion, 28th Infantry, 1st Infantry Division. Ronald was killed on February 6, 1968 from shrapnel wounds sustained in an explosion. Ronald Lee Koch is survived by his parents, a brother and a sister. He lived 20 years 1 month and 19 days. He is resting in Oak Grove Cemetery in Chelsea, Michigan. Ronald's name is listed on the Vietnam Memorial in Ypsilanti Township under Chelsea. His name also appears on the Vietnam Memorial in Washington, DC on Panel 37E Line 060.

Lieutenant Robert Clarence Marvin was born on February 10, 1940 in Boone, lowa to Mr. and



Mrs. Clarence R. Marvin of Dexter, Michigan.
Robert is a 1958 graduate of Greenville High School in Boone, lowa. Bob earned a Navy Scholarship and attended the

University of Michigan where he was a member of the Naval ROTC program. He was commissioned upon graduating in 1962. Lieutenant Marvin flew 111 missions from the U.S.S. Kitty Hawk before going to the U.S.S. Hancock with VA-115, Task Force 77, 7th Fleet operating in the Gulf of Tonkin, North Vietnam. According to a synopsis written on the POW Network, "On February 14, 1967, Marvin flew an A1H (Skyraider) from the Hancock on a mission. His plane developed trouble shortly after takeoff. He

and his wingman turned to return to the carrier, but Bob's engine stalled and cut off all electrical power, so no radio messages were received from him. His wingman tried to set a glide path to conform to the powerless glide Marvin's plane would be in, but never caught sight of Marvin's plane. The day was overcast. The Navy searched the area for two days but did not find any debris or sign of Marvin or his plane."

Robert Clarence Marvin is survived by his parents, wife, a son, and a brother. He lived 27 years, 3 months and 14 days. He was awarded 10 Air Medals, the National Defense Medal, Navy Commendation Medal and the South Vietnamese Government's Armed Services Expeditionary Medal. Robert's body was never recovered, but his name is listed on the Vietnam Memorial as "Missing In Action (MIA). His name also appears on the Vietnam Memorial in Washington, DC on Panel 15E Line 028.

Specialist 4 Jimmie Sherrill Warren was born on December 30, 1948 to Mr. and Mrs. Sherrill Warren of Milan, Michigan. Jimmie is a 1967 graduate of Dundee High School in Dundee, Michigan. He entered the Army in January



of 1968, completing his Basic Training at Fort Knox, Kentucky. Specialist 4 Warren began his tour of duty in

Cu Chi, Tay Ninh Province on August 16, 1968 serving as a Radio Operator with Headquarters and Headquarters Company, 2nd Battalion, 27th Infantry, 25th Infantry Division. Jimmie was killed on February 23, 1969 as a result of enemy small arms fire.

Jimmie Sherrill Warren is survived by his parents. He lived 20 years, 1 month and 23 days. He is resting in Shephard Memorial Park in Hendersonville, North Carolina. Jimmie's name is listed on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 31W Line 029.

Specialist 4 William David Gouger,

Jr. was born on May 3, 1949 to Mr. and Mrs William D. Gouger, Sr. of Ypsilanti, Michigan. William is a 1967 graduate of Lincoln High School. He attended Eastern Michigan University before entering the Army.

Specialist 4 Gouger began his tour of duty in Long An Province, South Vietnam on October 26, 1968 serving as an infantryman with E Company, 2nd Battalion, 60th Infantry, 9th Infantry Division. William was killed on February 11, 1969 from enemy small arms fire.



According to a posting by Joseph Bogucki, "I served in Nam with Bill Gouger with Recon 2nd/60th Inf. 9th Inf Div. We

called him 'Big G'. An avid hunter and outdoorsman. Bill was our platoon's unofficial armorer. 'G' was a big man, but as kind and gentle as any you would ever meet. Rest in Peace, Big G." William David Gouger, Jr. is survived by his parents and a brother. He lived 19 years, 9 months and 8 days. He is resting in Michigan Memorial Park in Flat Rock, Michigan. William's name is listed on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 32W Line 012.

Call to Order by President Harrison at 1905 hrs.

Pledge of Allegiance

Opening Prayer: Robert Bull Moment of Silence for POW/ MIA'S, their families and those who are serving in hazardous places around the world.

Roll Call: A quorum was established. Everyone attended via Zoom. Welcome Home Everyone!

New Members: None.

Guests: None.

Motion to approve the December Minutes as published in the Dispatch. Merritt/Driscoll. Approved.

President's Report:

I recommend that you stop by the

Resource Center at the VFW that Bob Bull has set up on Wednesday and Saturday from 9:30 to 5:00. Treasurer's Report: Reports were emailed to officers and board members. Printed reports or emailed reports were available for those members who wanted them. Our year-end non-restricted operating results are projected at a budget deficit of \$240, which is much better than the \$2,266 amended budget deficit we approved last spring. The improvement over budget is primarily due to the VAAAHS **Christmas Program donations** projected at \$14,380 compared to \$10,000 budgeted. The nonrestricted operating budget for next year is not much different that this year's. You can get a copy of the budget by emailing me. Members will vote on the final version of the budget at the February meeting.

AVVA Report: The report is printed in the Dispatch. We are collecting sample size toiletries and facial tissues for Fisher House. They are put in gift bags for the guests there.

Merchandise: No report.
Washtenaw County Council
of Veterans: Bull. The council
meeting was canceled due to
MDHHS restrictions.

Michigan State Council: Luker. No report.

Memorial Maintenance: Merritt. I am starting to put grass cutting teams together for next year. I am happy that most of this year's crews are coming back next year, but there are some vacant slots. Also, please let me know if you would be willing to help as a backup person or to help with special projects. Building

construction will have to wait for spring.

Website: McCrumb. Another 9,000 or so hits this month for a total around 250,000. We added pictures from the VA events (underwear delivery and the delivery of the embroidered shirts). Membership: The official number went down to 208 after Jim Graham passed away.

Newsletter: Pereira. No report.

Healthcare: Wilson. The VA is now giving Covid-19 vaccine shots by appointment to people aged 65 or older. I was able to get in and out in about 22 minutes. You need to call the VA at 734-222-7100 to get two appointments (because it takes two shots to be effective). VAAAHS: Kinzinger. We have given about \$9,000 worth of underwear and embroidered shirts to VA patients. I was happy to have help moving all the stuff. Thank you very much for being there, also. I'm doing better after my surgery, but I couldn't move anything when it needed to be done.

Old Business: None New Business:

Motion by Bull, seconded by Luker, to approve the attached resolution calling for Michigan to adopt the Green Alert system and directing the President to lobby as needed for its adoption by the State. Approved.

Good of the Order:

Bourne: A proposed budget has been developed for next year that predicts a deficit of about \$2,762. You may email me to request a copy of it. We will vote on it at the February meeting. We don't have much we can do with this budget, given that much of it involves fixed expenses. If we

can do any fundraising this year, we will happily adjust the budget accordingly.

Bourne: I still have a lot of cards for Holiday's Restaurant. We gave 4 to Fisher House, who could not accept them for reasons they didn't share. We gave 4 to Bob Bull for the Resource Center. He has used only one. We need to find people who need these.

Bull: Perhaps we could take a page from other organizations that ask members to contribute \$2 a month into an endowment fund. Interest earned on the funds is used to help with unbudgeted program expenses.

Kinzinger: Volunteered to chair a small committee to study the feasibility of doing a simpler Pig Roast, perhaps with prepared pork and without the raffles and auctions. Perhaps it could be set up as a drive-through event or socially distanced outdoor event, if restrictions are still in place. Sandie Wilson and Tim Driscoll volunteered to help. We hope to have a result by the February meeting.

Bull: The next open house for organizations using the VFW building will be on 20 March from 1000 to 1700, MDHHS regulations permitting.

Luker: The President vetoed the National Defense Authorization Act; but, since the House and the Senate voted to override the veto, it became law anyway. That means that bladder cancer, hypothyroidism and Parkinsonism are now included on the list of diseases presumed to be caused by toxic exposure in Vietnam (and other places). Although the VA has 100 days to implement the law, you should file your claim now (or file

your notice of intent to file a claim) if you want your retro check to be larger than it will be if you wait to file

The Attached Resolution:

Resolution: To adopt the Green Alert System for finding missing veterans in the State of Michigan Whereas: Over half of the veterans in Michigan are over 65 years of age, and

Whereas: Dementia is becoming a growing concern among these older veterans, many of them just walking away from their homes or nursing facilities, and Whereas: Many of our veterans also go missing because of stress and trauma associated with their military service to this country, and Whereas: The Amber and Silver Alerts have been so effective in helping to find missing children and seniors, and Whereas: Like the Amber Alert System, the Green Alert System is

activated immediately after notice is given of a missing veteran, not having to wait 24 hours to file a missing persons report, and Whereas: 39 other states have voted, ratified, and put into action a Green Alert System, and Whereas: An attempt to pass a bill in the US Senate, S699 the National Green Alert Act to help create a National System, has been stuck in committee since mid-2019.

Therefore: We do hereby resolve that to protect our aging veterans, to prevent any additional harm coming to them, and To give their families peace of mind knowing that there is an additional system in place to protect their loved one, in the event that it is needed, a Statewide Green Alert System must be adopted for our over 550,000 veterans, now and for their future.

Representatives Dingell and Walberg, Senators Peters and Stabenow applauded Passage of Bill to Rename Ann Arbor VA Facility after Lt. Colonel Charles S. Kettles. President Trump signed the bill in January 2021.

H.R. 2568 Vietnam Veterans Liver Fluke Cancer Study Act

The last movement of this bill was on May 29, 2019. This bill was referred to the Subcommittee of Disability Assistance and Memorial Affairs by the Committee on Veterans' Affairs. As of today, Thursday, December 17, 2020, there are 17 co-sponsors to this bill. Tim Walberg (R-I7) is the only Michigan US Congressman to co-sign this bill. If you live in another congressional district. please contact your representative to have him or her co-sign this bill. Our AVVA 310 has widows whose Veteran husbands suffered and died from Liver Cancer. Please consider writing your US Congressional Representative to support this bill in honor and memory of them.

Kettles Honored

Legislation has been officially signed to rename the Department of Veterans Affairs Medical Center (VAMC) in Ann Arbor after Lt. Col. Charles S. Kettles. Here is a summary of the heroic deeds carried out by Lt. Col. Kettles: In May of 1967, Lt. Col. Kettles led three rescue flights into enemy territory to deliver supplies and to evacuate soldiers caught in an ambush. In the middle of the final flight, Kettles was informed that eight soldiers remained on the ground. Without hesitation, Kettles turned around and proceeded to rescue the remaining men. His actions saved the lives of 40 soldiers and four crewmembers. In retirement, Kettles was a mentor, a friend, and a fellow veteran in the community.
