#### **President's Report:**

#### Treasurer's Report: Bourne

Reports were emailed to the Board and to members who wanted one. Let Bourne know your email address if you desire these reports.

Nonrestricted funds revenue increased by a \$500 donation earmarked for WACU and by \$1,090 merchandise sales at the VA (less \$776 cost of goods sold). The only significant expense was \$500 sent to Washtenaw Community College for VetFest happening on 3 August. On restricted accounts, the Christmas fund revenue reached \$19,232 making it the second-best year so far.

For the fiscal year, our total revenue was \$8,368 more than our budget predicted while our expenses were

\$9,999 less than our budget predicted. approved by the Board

Our annual financial reports have been sent to VVA National and to Michigan State Council. We will next perform our internal audit as per Board approved policy.

#### **Committee Reports**

**Merchandise:** Merchandise annual physical inventory was completed. The next merchandise sale at the AA VA will be Wednesday (instead of our usual Tuesday), 20 March 2024. We always could use help. We load in at 0730 and sell from 0800 until 1400. Also, our new tent is in and is easier to set up, but it still takes 4 or 5 people so we will still need volunteers. And our new challenge coins are in. We sell them for \$5 each. We do take a few cents loss on each sale, but we spread the word, so it is worth it. Last time we bought coins, we made a few cents on each.

**Washtenaw County Council of Veterans:** The next meeting is 18 March.

**Michigan State Council:** Wilson. The National Board voted to do away with in-house attorneys. The move save \$600,000 a year. The work is now being hired out.

The State Council's annual meeting and convention will be 1-2 June in Marquette. The \$50 registration fee includes lunch and supper. Big Mac is under construction so expect a delay.

**Memorial Maintenance:** Annual Spring Cleanup will be at 1000 on 16 March. Home Depot is helping again this year with a donation of equipment and supplies, and they will send volunteers to the clean-up day as well.

On 29 March (Vietnam Veterans Day) at 1000, we'll have a dedication ceremony at the Vietnam Memorial for the Washtenaw County Vietnam Veterans Memorial Highway signs.

**Website:** We have had around 422,000 hits since the website was last rebuilt. We've stopped the front-page slide show and made a few other small changes.

**Membership:** We are at 218 members.

**Newsletter:** McCrumb. The newsletter is being redesigned. Paulo and I are working on a new front-page design. Also, there is now only one column. If you click on the picture of those named on the wall, you will be taken to the website page that tells what we know about that person.

**Health Care:** Sandie Wilson – As you know, VA Secretary Denis McDonough has refused to implement federal law requiring the VA to study toxic exposures. He now claims that there is not sufficient information about birth defects to perform the research. That means there is yet another reason to encourage anyone who has a child with a birth defect to register that child with Birthdefects.org. It is not just for veterans, but civilians also. Another reason is because the registry makes it possible to do other research that can't be done any other way. For example, researchers learned that 60% of those diagnosed with autism were born of women who took Tylenol for pain during pregnancy.

We will do at least seven this year and maybe as many as ten.

### **Honoring April Anniversaries on the Wall**

**Corporal William Henry Johnson** was born on December 9, 1943, in Union City, Tennessee to Jewell and Johnnie Johnson of Ann Arbor, Michigan. William is a 1961 graduate of Ann Arbor High School. A caption in the Ann Arbor High School Yearbook for 1961 states, "Willie came to Ann Arbor High from Slauson. While at the High School, he participated in all intramural sports. He also likes to swim. His plans for after graduation are not yet definite. He will either work or join the Army." William enlisted in the Marine Corps in August of 1963 going through Marine Corps Boot Camp at Marine Corps Recruit Depot, San Diego, California. He received further training at Camp Pendleton, California before going

to Okinawa.

Corporal Johnson began his tour of duty near Danang, Quang Nam Province, South Vietnam serving as a rifleman with E Company, 2nd Battalion, 9th Marines, 3rd Marine Division, III Marine Amphibious Forces. William

was killed on April 17, 1966, because of small arms fire from a sniper while manning a defensive position.

William Henry Johnson is survived by his parents, a sister, and a brother. He lived 22 years, 4 months, and 8 days. William's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 06E Line 119.

**Private First Class Clive Vere Mosier** was born on January 3, 1943, in Campbell, Misso to Mr. and Mrs. John Mosier of Chelsea, Michigan. Clive was employed as a foreman with Seller's Construction Company before entering the Army on September 1, 1966. According to his wife, "he was known as "Buster" by all his family and friends. Clive loved baseball. His favorite foods were chocolate chip cookies and fried chicken. He sent a picture of him holding a little Vietnamese girl. He said in his letter, 'Honey, I miss you greatly, but these people need us. No one else will help them. We have to."

Private First Class Mosier began his tour of duty in Military Region 3, South Vietnam on February 16, 1967, serving as an infantryman with B Company, 5th Battalion, 7th Cavalry, 1st Cavalry Division.

Clive was killed on April 24, 1967, because of an explosive device.

Clive Vere Mosier is survived by his wife, parents, and four brothers. He lived 24 years, 3 months, and 21 days. He is resting in Arborcrest Cemetery in Ann Arbor, Michigan. Clive's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 18E Line 080.

First Lieutenant Robert John Crabbe was born on June 12, 1941. First Lieutenant Crab began his tour of duty in Binh Dinh Province, South Vietnam on January 11, 1966, serving as a Field Artillery Unit Commander with Headquarters, Headquarters Battery, Division Artillery, 1st Cavalry Division. According to a posting by fellow Field Artillery Officer Candidate School Alumni from Fort Sill, Oklahoma, Randy Dunham, "First Lieutenant Crabbe served as an Aerial Observer with the First Cavalry Division. He was in a UH-1C Helicopter Gunship from Troop A, 1st Squadron, 9th Cavalry that was shot down while making a rocket run on a Viet Cong position. All five men on board the aircraft died in the incident." He was killed on April 18, 1967, after serving one year, three months and seven days "In-Country."

Robert John Crabbe lived 25 years, 10 months, and 6 days. He is resting in Arlington National Cemetery in Arlington, Virginia, Section 4, Site 2969-C. Robert's name is listed on the Vietnam Memorial in Ypsilanti Township under

Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 18E Line 045.



**Sergeant First Class Michael Jon Wallace** was born on November 21, 1939, in Ann Arbo Michigan. Sergeant First Class Wallace began his tour of duty in Thua Thien Province, South Vietnam at Camp Evans serving as a CH-47 Helicopter Repairer with B Company, 228th Assault Helicopter Battalion, 11th Aviation Group, 1st Cavalry Division. On April 19, 1968, three Army helicopters were shot down in the A Shau Valley of South Vietnam. All three were making supply runs to Landing Zone Tiger in Quang Tri Province. Five men survived the three crashes, and nine men remain missing. On April 19, 1968, Michael was a crew chief on a CH-47 Chinook helicopter flying a mid-day supply mission. The helicopter was descending through an overcast sky and was on its final approach to Landing Zone Tiger in Quang Tri

Province when it was struck by enemy .50 cal and 37mm ground fire, caught fire and began to burn. The gunner witnessed Michael and the flight engineer, Anthony Housh, jump from the helicopter when it was about 100 feet off the ground. The aircraft crash landed, and the remainder of the crew was rescued. Michael's body was never recovered, and he was listed as Missing In Action (MIA). On February 6, 1974, Michael's status was changed to

"Died While Missing In Action."



Michael Jon Wallace is survived by his wife and two children, and a sister. He lived 28 years, 4 months, and 28 days. He is remembered with a Military Marker in East Oak Grove Cemetery in Chelsea, Michigan. Michael's name is listed on the Vietnam Memorial in Ypsilanti Township as MIA. His name also appears on the Vietnam Memorial in Washington, DC on Panel 51E Line 002.

**Private First Class James Roy Bihlmeyer** was born on November 12, 1946, in Manchester, Michigan to Mr. a Mrs. Roy J. Bihlmeyer. James is a 1965 graduate of Manchester High School. He worked at the Saline Plant for Ford Motor Company prior to entering the Army on May 16, 1966.

Private First Class Bihlmeyer went through Basic Training at Fort Riley, Kansas. James began his tour of duty in Long An Province, South Vietnam on December 1, 1966, serving with A Company, Second Battalion, 60th Infantry, 9th Infantry Division as an infantryman. He died because of enemy small arms fire on April 15, 1967.

Private First Class James Roy Bihlmeyer is survived by his parents, a brother, and a sister. He lived for 20 years, 5 months and 3 days. He is resting at the Bethel Church Cemetery in Manchester, Michigan. His name is listed on the Vietnam Memorial in Ypsilanti Township under Manchester. James Roy Bihlmeyer also appears on the Vietnam Memorial in Washington, DC on Panel 18E Line 028.

## The 22aday.org Project

As a Past President of VVA Chapter 310, I am very proud to be writing this article for our award-winning Dispatch! When Al Merritt first contacted me last November, he told me about a project that our Veteran organizations in Sebastian, Florida might be interested in, "22aday.org." I was taken at such a wonderful program to create awareness and to alert the public about how serious the veteran suicide rate is.

I communicated to each local Sebastian Veteran organizations, and they responded they either had no property or were too busy for such a project. I then thought about our Knights of Columbus Fourth Degree Assemblies. Their main charge is Patriotism. I am the District Deputy for Florida District 62, which is in Indi-



an River County, Vero Beach, and Sebastian. We have three 4<sup>th</sup> Degree Assemblies and four 3rd Degree Councils that I have jurisdiction over.

I introduced the project at my K of C home Assembly 2194 membership meeting in Sebastian. It was immediately met with resounding enthusiasm and instant unanimous approval! Subsequently I brought up this project at all our K of C Assemblies and Councils in District 62. Same result: they said this is a project that they would sponsor and support! No one could remember if there ever was any project in the district that was a joint effort amongst all the K of C organizations!

Jon Luker and Wendy Hibbitts said they would come down with the equipment trailer after they picked it up in North Carolina. We kicked off the project with a Sunday dinner at my house. They hadn't had a home cooked meal in several days. We had a fun time reminiscing and starting to make final plans for our local display.

On the following Monday we began the grounds preparation. The layout would be challenging as the St. Helens Catholic Church property was not a rectangle, but a triangle. Jon was able to figure out a layout that would take advantage of the Church front property that bordered along a very busy intersection in Vero Beach. Ron Hunkapiller, Faithful Navigator (president) of K of C Assembly 1932, volunteered to be the St. Helens contact. We were also very fortunate to have a very dedicated new member of his Council, Chuck Roach, help with the initial layout. I was amazed at the amount of preparation necessary to insure we had a very military like precision layout. We spent most of that entire Monday measuring right triangles and laying a few hundred yards of stringlines and stakes.

On Tuesday we had a very good turnout of about 20 volunteers present for the training necessary to understand how to place the 22 crosses daily. Then, for the next 30 days at St. Helen Catholic Church, Vero Beach, Brother Knights, their families, and friends placed 22 crosses a day for an impactful total of 660 crosses. They created an experience that gave the community a visual idea, helping us all understand the significance of the veteran suicide problem, and to challenge us to pray and discern what we can do to combat this unnecessary loss of lives.

The project went very smoothly, with plenty of daily volunteers. However, we did have one scare as the City of Vero Beach issued a Code Violation for too large of an advertising display in public view. To complicate it more, they ticketed the Bishop of West Palm Beach (Church property was in his name)! We were fortunate that Ron Hunkapiller knew a police lieutenant who talked with the City Code Enforcement division to allow us to continue. They said they supported us and to ignore the daily \$50 fines.

Citizens visited the site to learn more about veteran suicide and what can be done to prevent it and were encouraged to write a veteran's name on a cross so that we will never forget them. Many stopped by to recite prayers and rosaries, as well as thanking Veterans present. Monetary donations were accepted for the Veterans 501(C)3 "22aday.org" organization. It is estimated over 200-man hours of labor supported this faithful and patriotic awareness project! In the end we all hoped that we made a difference, and we believe we did!

#### What is WACU?

Perhaps many people wonder what WACU is all about. Let me explain how it came to be.

I began my involvement with Veterans in 1986, when I joined VVA310. For years, an issue that hauntingly developed within me was how I might be able to impact the Veteran suicide issue. Survivor guilt seemed to be my motivator. Maybe I could somehow save one Veteran. I attended symposiums and lectures; I met with doctors and combat Veterans; I gathered my thoughts about that issue—and all the while I kept on asking: What might I do?

Our Lord directed me to a friend at the VA hospital. She was a mental health supervisor. My question for her was, "What does the VA do for the caregiver who is there when the warrior has a post traumatic stress episode?" At that time it was 2014--and they were doing very little for caregivers. My search was over. That is when I began Warriors And Caregivers United. Since then, I have come to believe that, truly, we are the first organization in the United States to consider both warrior and caregiver as equals in addressing the suicide issue.

In fact, recently at a WACU caregiver retreat, nearly half of the caregivers admitted they had considered suicide in the past six months. That discovery highlighted the importance of our work directing our efforts for the warrior through the family versus just the warrior.

We have put on events around lower Michigan for our WACU community, for just the warriors, and also for just the caregivers. Our primary focus is events for the family. We have testimonials from several, in which they admit that WACU has made a difference in their lives. And several admitted that, had it not been for WACU, they would have attempted suicide. We, Board members, have adopted the saying, "Let us save One more" as our mantra. That is the name of our May 17th fundraiser at the Ypsilanti Depotown Freighthouse. The program will be 6-9pm with wonderful entertainment, testimonials, and a live auction. There will be a \$15 cover charge.
