President's Message

There is an old saying that, if you keep doing what you've been doing, you'll keep getting what you got. This saying is often used to help managers get the idea that, if they don't like what they are seeing, they must embrace change. If they still don't get it, we'll tell the managers that one way to determine insanity is to do the same thing again, expecting a different result.



Why do I bring that up now?

Although I'm happy with most of what I see, I wonder what we would see if different people were helping to call the shots. Actually, that's not the honest truth. The real reason I said that is because elections are coming up, and it is time for the membership to nominate and elect new people who are willing to serve. And it is time for new people to make themselves known and to show their interest in helping the Chapter continue its growth and its tradition of service to the veteran community.

I don't mean any offense to any current office holder or past or present board member when I say that the one exception to the above is that I hope we elect Berry one more year. The change he has been leading the past several years have given us a much better

understanding of our financial picture. The tools he uses to log day-to-day operations lead to nearly automated monthly financial reports and fill out the annual tax return properly. Our merchandizing operation has been included in the accounting process now as well. I think if he is willing and able to stay on the job one more year, that will give us time to become more familiar with our finance records and to train somebody to do the day-to-day bookkeeping.

We have only one officer who has not been on the job very long, but he has been an active member of the Chapter for some time. Unfortunately, I fear his health is not going to permit him to accept nomination to office again. Everybody else has held more than one job and has served on the board or as an officer (or both) for several years.

Not that there is anything "wrong" with having the same people run the show year after year, but we could be missing out on things because we tend to just keep doing what we've been doing. Well, not really. We cater the Annual Dinner now. We don't do public awareness events anymore. We don't do merchandize except at the VA and one other place. It looks like we don't do the Pig Roast anymore. We will downsize our presence at the Heritage Festival. Very few people "march" in parades anymore. That's not a complaint. We are just not as physically fit as we once were, and we are spending more time with grandkids than before.

I've spoken before about the vote that will take place at the Convention in Spokane in July. That will shake things up at the Chapter in a few years, if not sooner. Voters will hear from two groups. One group will explain how VVA will finally close its doors. Because the federal charter can't be amended, we will, in time, not have enough members left to get things done. In order to do right by the people who have claims in the system, and also do right by donors, we can't just wait for the last person living to turn out the lights. Group One is making the plan to wind down service operations and to address "property rights" and so forth. There is another work group that is figuring out how Vietnam Veterans and their supporters can transfer the mission of the VVA to people who are not allowed to join VVA. so that the mission continues. Members will vote on whether to implement a plan that will transfer our mission, our income sources. our processes, and our property to a brand-new service organization.

No matter how that vote comes out, every State Council and every Chapter faces a changing future. They will run out of members, and the mission will remain undone. Something different is in our future, guaranteed. Fortunately, the Great Lakes Councils have already begun planning for what comes next. Also, fortunately, the Councils and Chapters don't have to do exactly the same thing the National organization chooses to do.

It may seem like I'm wandering a bit here. So, let's bring it back to the basics. Elections are coming up for the Chapter in April. I believe now would be a great time for a few newer members to step into leadership roles, partly to share the load with those who have been doing the work for decades, and partly to bring new energy and new ideas to the table as we look forward to the next few years of change at

the national level that will impact what we do locally.

Our membership continues to grow in part because people recognize that we do important work, and we do it well. Once people find out about it, they want to be a part of it. After you join, becoming an officer or a board member is your next step. There is a lot that we are doing well and don't need to change. Make no mistake about that. I'm proud of the Chapter and AVVA, and I'm grateful for our donors, who recognize and support the good we do. However, like it or not, change is coming. I think it would be great if we could get a couple new people in leadership roles who are excited about helping the Chapter embrace change and carry the good work we do into the next phase of our existence.

Earl worked for United Air Lines as a flight food handler at Detroit Metropolitan Airport.

Specialist 4 Hoag entered the Army on April 20, 1968 completing his Basic Training at Fort Ord, California and Advanced Training at Fort Polk, Louisiana. He began his tour of duty in Thua Thien Province, South Vietnam on August 19, 1968 serving as an infantryman with B Company, 2nd Battalion, 502nd Infantry, 101st Airborne Division. Earl was killed when his patrol was ambushed and



he sustained m u l t i p l e fragmentation wounds on March 8, 1969. He died just one day before his 21st Birthday. Earl Thomas Hoag is survived by his parents and three brothers. He lived 20 years, 11 months and 29 days. He is resting in Grand Lawn Cemetery in Detroit, Michigan. Earl's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 30W Line 076.

Private First Class Frank Leslie Keck was born on June 1, 1946. Frank attended Saline High School in Saline, Michigan for six years returning to Kalkaska, Michigan after the death of his father in 1965. He would have been in the 1964 graduating class in Saline where he played varsity basketball. He worked in construction before entering the

Frank Leslie Keck is survived by his wife and son, his mother, and one brother. He lived 22 years, 9 months and 28 days. Frank's name is listed on the Vietnam Memorial in Ypsilanti Township under Saline. His name also appears on the Vietnam Memorial in Washington, DC on Panel 28W Line 082.

Corporal Gregory Randall Shambaugh was born on October 2, 1947 in Ann Arbor, Michigan to Mr. Robert Shambaugh of Toledo, Ohio and Mrs. Geraldine Shambaugh of Ann Arbor, Michigan. Gregory attended Carpenter School, Tappan Junior High School and Ann Arbor High School. He went on to graduate



in 1966 from Howe Military School in Howe, Indiana. Gregory attended Eastern Michigan University in Ypsilanti, Michigan

before enlisting in the Army on January 19, 1967.

Corporal Shambaugh began his tour of duty in Thua Thien Province, South Vietnam serving as an infantryman with D Company, 1st Battalion, 502nd Infantry, 101st Airborne Division. According to First Lieutenant McLemore in a letter to Mrs. Shambaugh, "On March 6, 1968, while Gregory was participating in a search and destroy mission with Company D, 1st Battalion, 502nd Infantry, he was struck by an enemy bullet and instantly killed." The Bronze Star Medal was posthumously presented to Mrs. Shambaugh.

Gregory Randall Shambaugh is survived by his parents and his wife. He lived 20 years, 5 months and 4 days. He is resting in Arborcrest Cemetery in Ann Arbor, Michigan. Gregory's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 43E Line 034.

January Meeting Minutes: A **motion** was made by Marv Rivers to accept the 10 Jan 2019 meeting minutes as posted in the Dispatch. Seconded by Marty Cothorn. **Motion passed.**

President's Report:

Jon Luker discussed three items.

1) Reference to LTC Kettles death

and a memorial, yet be to decided, to be erected on site sometime in the future; 2) A card is being passed around to send to Mrs. John Dingell in honor to his service to his country first as a veteran, then 59 years in the U.S. House of Representatives; and 3) the flag at the VVA 310 Memorial in Ypsilanti will remain at full staff except for the following three occurrences: 1) a sitting U.S. President has died; 2) a sitting U.S. President is lying in state in the Capitol Rotunda; and 3) a sitting U.S. President is buried.

Treasurer's Report:

Bourne reviewed Berry the salient points on the Financial Report handout. He covered four significant events/transactions: 1) Certificate of Deposit transactions were completed in mid-January; 2) \$900 Memorial donations were received for LTC Charles S Kettles memorial yet to be determined. It is anticipated that over \$2,500 will ultimately be received, 3) A \$3,000 payment to WACU was made from the AA VA HS restricted account, and 4) \$3,500 was received today from the Merchandise Committee generated from sales in excess of their working capital requirements. Merchandise has contributed \$7,480 to the Chapter this fiscal year.

AVVA Report: In Kathy Driscoll's absence, Meni Draper gave the report. See Kathy Driscoll's full report on AVVA activities as part of the monthly Dispatch newsletter.

Food Pantry: No report

Calendar Committee: David Draper reported that a few items have been inserted. He requested to contact him on all pertinent meetings dates so he can update the calendar. Beverly Conatser will be given a

special gift at the Recognition Dinner on May 4th.

Merchandise Report: Marv Rivers stated that February merchandise sales were low due to the ice storm in the area. He also thanked all that have assisted the Merchandise Team this fiscal year.

Washtenaw County Council of Veterans Report: Jon Luker reported the Annual Appreciation Dinner will be March 18th. The Chapter has purchased 10 tickets at \$10 each for VIP's that will probably go unused due to federal employees buying their own tickets pursuant a conflict of interest policy.

Michigan State Council Report: President Jon Luker stated that the next meeting is in March. Memorial Maintenance Report: Al Merritt reported that there is consideration of adding a shed to the site and investigating the possibility of bringing water to the site. Project magnitude depends on funding.

Website Report: Vance McCrumb stated that website is working well. He is working to make the site secure.

Membership Report: Vance McCrumb stated that with the addition of Barry Harrand less LTC Kettles and Al Merritt's brother, the chapter membership totals 203.

Newsletter: Any software was purchased to enhance presentation

in the letter. Paulo-Juarez Pereira is training on how to use this new software.

Health Care: It was mentioned by Jon Luker that Blue Water Navy won its lawsuit.

VAAAHS Report: In John Kinzinger's absence, Dave Draper commented that the Valentine Party was held today at the VA with Ms. Washtenaw County in attendance. She is a strong supporter of Veterans. The event was well received by the Veterans.

Vietnam, Iran, and Brazil: What Was and What Could Have Been in 1964

This year, 2019, the world remembers the Iranian Revolution, carried out under the leadership of Ayatollah Khomeini. The Iranian Revolution gave origin to the Islamic Republic of Iran after overthrowing the Shah of Iran, who was Mohammad Reza Pahlavi. I am mentioning these points of Iranian history in order to show that, as far back as 1964, Ayatollah Khomeini had attempted to overthrow the Shah of Iran, and he failed. I will make a connection between the historical facts in Iran and the Vietnam War. My goal in this note is to show how the Vietnam War made a difference, both in Iran and in Brazil.

The Ayatollah Khomeini did not succeed in his revolutionary efforts in 1964 due to lack of assistance. In this context, one could question why the Soviet Union did not intervene to assist Ayatollah Khomeini in his effort to depose the Shah in 1964, since Khomeini was against the

United States, and Iran has always been viewed as a potential ally of the Soviet Union, and later Russia. I present two reasons why the Soviets did not offer assistance to Khomeini, First, the leadership of the Soviet Union was in transition, as power was being transferred from Nikita Khrushchev to Leonid Brezhnev. But there was a second reason—and this is the one I am interested in, because it involves the Vietnam War. Contrary to expectations after the death of Pres. John F. Kennedy, the new U.S. leader, Pres. Lyndon Johnson, did not withdraw U.S. advisers from South Vietnam but instead began to strengthen the U.S. presence in South Vietnam. Therefore, Soviet attention became strongly focused on Southeast Asia, not the Middle

In fact, things in the United States were happening fast in 1964, but it was clear that the U.S. resolve to engage North Vietnam militarily was strong and growing. Just a few months before Khomeini's attempt to overthrow the Shah of Iran, U.S. Pres. Lyndon Johnson had moved the Gulf of Tonkin Resolution through Congressional approval, which authorized Pres. Johnson to use military force in Southeast Asia. The Gulf of Tonkin Resolution must have shocked the Communist world. who expected no such resolve from Pres. Johnson. In mercurial fashion. the United States began to amass military forces in South Vietnam, with U.S. allies' support. This forced the Soviets to focus on South Vietnam rather than Iran, Lattribute. therefore, to the Vietnam War the fact that the Soviets did not support Ayatollah Khomeini in his efforts to depose the Shah of Iran in 1964.

What is, then, the significance of Ayatollah Khomeini's failure to depose the Shah in 1964? The significance is that Khomeini was relatively young then, a charismatic individual who could have united the Islamic world with the support of the Soviet Union, to create a formidable axis of power against the United States. As it turned out, Ayatollah Khomeini had to wait 14 years to defeat the Shah, when the United States was already out of Vietnam, and the Soviet Union was showing signs of weakening. I attribute these historical facts to the Vietnam War; again, this shows that the Vietnam War was the stitch in time that saved nine. Next, I will mention and event in Brazil.



Brazil's Revolution Against Communism in 1964

There was something else that did not happen in 1964. Again, Lattribute these results to the Vietnam War. Following the resignation of then Brazilian President Jânio Quadros, Vice President João Goulart, from the Communist Workers Party, assumed power while he was visiting Mao Zedong in China. Pres. Goulart was, however, a weak president, and the country quickly fell into chaos. Thus, in 1964, U.S. Pres. Lyndon Johnson provided assistance to Brazil's revolutionary movement to depose Pres. João Goulart and install a military regime, in accordance with the Brazilian Constitution, which foresees that the Brazilian Armed Forces are

authorized to take over power in case of national chaos. Without U.S. assistance, it is unlikely that Brazil would have pushed away the Maoist revolution that was taking place all over the country, and Brazil could have become a Communist bastion in South America. And here is the connection to Vietnam: What gave Pres. Johnson the credibility that he was motivated to defeat Communism was his decision to become involved in South Vietnam. Seeing U.S. resolve in South Vietnam, Brazilians became emboldened to take action and thwart the Communist revolution in Brazil.

In conclusion, I come back to a point I have made in other notes: The purpose of the Vietnam War was to make things not happen; in other words, to prevent bad things. I believe the U.S. warriors in Vietnam succeeded in more ways than people realize, and therefore, they deserve credit.

Our VVA310 Chapter members and AVVA Associates have made admirable efforts toward building a Fisher House in Ann Arbor. Thus, members and Associates are likely familiar with the remarkable





programs implemented by the Fisher House Foundation. But the Foundation's story of success and generosity deserves retelling, for their amazing vision and remarkable accomplishments.

Founded in 1990 by Zachary and Elizabeth Fisher, the non-profit

veterans, and their families by providing comfortable temporary housing facilities near hospitals and VA medical centers while their loved ones are receiving medical treatment. Thus, they have touched the lives of many military and veterans families. Their services are especially useful for family members who need to travel from distant locations in order to be with loved ones in hospitals and VA health facilities.

With the assurance that there is never a lodging fee, Fisher House saves military and veterans' families in costs for housing and transportation during hospitalization of a loved one.

The average stay is 10 days, but it can last longer, depending on need. The Fisher House Foundation even facilitates transportation to bring family members from distant locations. For that, they use donated frequent flyer miles. They may even use donated hotel points to arrange for family members to stay at hotels near hospitals and VA medical centers.

In difficult times, when family membrers need to travel and make arrangements for accommodations, Fisher House is there for them, with understanding, caring, comfortable accommodations, and smart travel arrangements.

Hundreds of thousands of current and former military families have made use of the many programs offered by the Fisher House Foundation. Since its inception, the Fisher House Foundation has helped families save an estimated half a billion dollars in costs.

By using their own expertise, the Fisher House Foundation builds homes in government property. Once the homes are ready for



occupation, the Foundation donates the homes to the VA or the military. From that point on, the VA or military will take over the operation and maintenance of the homes.

Through their inspiring vision and generosy, Zachary and Elizabeth Fisher have created a charity model that has escalated into many different areas. By collaborating with other charities, the Fisher Foundation can touch the lives of service members and veterans in many different areas, showing how generosity is like flowers in spring: It grows and multiplies.


These quilts have been created by Shirley Hitte and will be donated to the Fisher house. These are meant to be lap quilts for veterans.
