## Chaplain's Corner

I would like to build upon July's leadership theme, as we close in on the national elections, by looking at leadership from those in the position. What does a person who is godly do when surrounded

by those who oppose God's will and direction? What is the focus of a person in that kind of position? Amazingly, we do have an example from a powerful and godly king in Scripture to look at. David had his faults, to be sure, because he was housed in the weakness of the flesh, but God Himself declared David to be a man after God's own heart (a phrase for someone wanting to do God's will). David recorded his heart's plea and thoughts in Psalm 35. It has 28

verses, and each verse tells of the



soul's struggle to keep God the main focus when in leadership and to allow God to help in the battle for righteousness.

Plead my cause, 0 Lord, with them that strive with me: fight against them that fight against me. Take hold of shield and buckler, and stand up for mine help. Draw out also the spear, and stop the way against them that persecute me: say unto my soul, I am thy salvation. Let them be confounded and put to shame that seek after my soul: let them be turned back and brought to confusion that devise my hurt. Let them be as chaff before the wind: and let the angel of the Lord chase them. Let their way be dark and slippery:

and let the angel of the Lord persecute them. For without cause have they hid for me their net in a pit, which without cause they have dug for my soul. Let destruction come upon him at unawares; and let his net that he has hid catch himself: into that very destruction let him fall. And my soul shall be joyful in the Lord: it shall rejoice in His salvation. All my bones shall say, Lord, who is like unto Thee, which delivers the poor from him that is too strong for him, yea, the poor and the needy from him that lays waste to them? False witnesses did rise up; they laid to my charge things that I knew not. They rewarded me evil to good to the spoiling of my soul. But as for me, when they were sick, my clothing was sackcloth: I humbled my soul with tasting: and my prayer returned unto mine own bosom. I behaved myself as though he had been my friend or brother. I bowed down heavily, as one that mourns for his mother. But in my adversity they rejoiced, and gathered themselves together: yea, the abjects gathered themselves together against me, and I knew it not; they did tear me and ceased not: with hypocritical mockers in teasts, they gnashed upon me with their teeth. Lord, how long will you look

on? Rescue my soul from their destructions, my darling from the lions. I will give you thanks in the great congregation; I will praise you among much people. For they speak not peace; but they devise deceitful matters against them that are quiet in the land. Yea, they opened their mouth wide against me, and said, Aha, aha, our eye has seen it. This you have seen, 0 Lord: keep not silence: 0, Lord, be not far from me. Stir up thyself, and awake to my judgment, even unto my cause, my God and my Lord. Judge me, 0 Lord my God, according to your righteousness; and let them not rejoice over me.

Let them not say in their hearts, Ah, so would we have it: let them not say, we have swallowed him up. Let them be ashamed and brought to confusion together that rejoice at my hurt: let them be clothed with shame and dishonor that magnify themselves against me. Let them shout for joy, and be glad, that favor my righteous cause: yea, let them say continually, let the Lord be magnified, which has pleasure in the prosperity of his servant. And my tongue shall speak of Your righteousness and of your praise all the day long.

David's prayer and thoughts are so poignant to our world, nation, and state today, so much so that we should pray a similar prayer for righteous leaders that this next election will reveal the Righteousness of our Lord God. Peace and safety to all, Gordon

### Honoring August Anniversaries on the Wall

Lance Corporal Kendal Lee
Benney, Jr. was born on February
22, 1948 to Mr. and Mrs.Kendal
L. Benney of Ypsilanti. Kendal
lived with his father and stepmother in Big Rapids, Michigan
until September of 1965 where he
attended Ypsilanti High School. He
left Ypsilanti High School during
his Junior year and enlisted in the
Marine Corps in March of 1966.



Lance

Quang Nam
Province,
South
Vietnam in
December

of 1966 serving with C Company, First Battalion, Seventh Marines, First Marine Division as a machine gunner. Kendal was killed on August 20, 1967 while standing watch when he suffered multiple fragmentation wounds from a bomb.

Lance Corporal Kendal Lee Benney, Jr. is survived by his mother, father, step-mother, two sisters and one brother who was serving in South Vietnam when Kendal was killed. Kendal's brother was discharged from the Army and escorted his brother back to the "World" for internment. Kendal lived 19 years, 5 months and 28 days. He is resting in the Altona Cemetery in Altona, Michigan. Kendal's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 25E Line 018.

**Private First Class James William** Davis was born on March 24, 1947 in Erie, Pennsylvannia to Mr. and Mrs. William A. and Gretchen Raub Davis. James grew up in Belleville, Michigan, but lived in Ypsilanti. He is a 1965 graduate of Belleville High School where he lettered in football and swimming. James attended Michigan State University and Cleary College. James was employed as a customer agent for Trans World Airlines at the Detroit Metropolitan Airport in Wayne, Michigan prior to his to entering the Marine Corps on December 13, 1968.



Private First Class Davis began his tour of duty in An Hoa, Quang Nam Province, South Vietnam on July 7, 1969 serving as a rifleman

with I Company, 3rd Battalion, 5th Marines. 1st Marine Division. James was killed on August 13, 1969 as a result of small arms fire just one month and six days into his tour of duty "In-Country". James William Davis is survived by his wife, an 11 month old son, his parents, and two brothers. He lived 22 years, 4 months and 10 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. James' name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 19W Line 029.

Our deceased friend and fellow Vietnam veteran LTC Charles S. Kettles has been honored yet again with the renaming of the Ann Arbor VA facility, as indicated in the article mentioned below. The Kettles story surely will be remembered and honored.

#### **Article reference**

Here's part of the article (see link below):

WASHINGTON, DC - U.S. Senators Gary Peters (MI) and Debbie Stabenow (MI) and U.S. Representative Debbie Dingell (MI-12) today introduced bicameral legislation that would rename the Department of Veterans Affairs Medical Center (VAMC) in Ann Arbor after Lieutenant Colonel Charles S. Kettles. Li eutenant Col onel Kettles, a lifelong resident of Ypsilanti who passed away in January of 2019, served in the Vietnam War as an Army helicopter commander and was awarded the Medal of Honor in 2016 for leading a rescue operation that saved 44 soldiers.

# Important Facts of UVA310's History, Continued, Part V

Shortly after having our request denied, our Memorial committee met to discuss our next step. Mrs. Lois Brown and Mrs. Della McIntire, along with KIA father Mr. Chester Brown, joined our discussion at a nearby restaurant. We discussed whether we should proceed with an attempt to get the Ann Arbor City Council to override the Park Advisory Commision's decision.

Our committee knew that if we succeeded with that, we would have to go back and deal with the same anti-Memorial Parks Advisory Commission. Because of that, we voted to look for another location for our beloved Memorial. Mr. Brown, retired Ann Arbor fireman and father of Ann Arbor KIA Charles "Chuckie" Brown, supported our looking elsewhere. He certainly opened our eyes when he said, "You would not want to have the Memorial defaced by some Ann Arbor anti-war radicals. Can you imagine how you would feel if you drove by it and noticed that it had been all painted up?" For the next few weeks in the newspaper and on local radio programs, people criticized the decision of the Parks Advisory Commission and the City of Ann Arbor. We Memorial Committee members decided not to get involved and let the general public make their feelings known. We had scratched Ann Arbor off our list. We received several notes like the following from Mrs. Esther Bihlmeyer, mother of KIA Jim Bihlmever.

I read that the Parks Advisory Commission turned you down. How selfish of them! I can imagine you fellows disappointment and bitterness. I am sure with your ability and effort things will turn out for the better.

It is impossible to know how terrible the county KIA family members must have felt about the Parks Advisory Commission rejection. For the two Ann Arbor mothers who witnessed the rejection, it was obvious how terribly hurt they felt.

Mrs. Lois Brown, mother of Charles Brown, wrote the following:

The time has come that I can no longer stand back and say nothing, while a very special group of young men try to get a memorial built honoring the boys of Washtenaw County who died or are still missing in Vietnam.

As I understand it, what the Vietnam Veterans Memorial Committee are asking of the Ann Arbor Parks Advisory Commission is a spot of land in Veterans Memorial Park to build a memorial. They are not asking for money to build with, nor are they asking for the Commission to maintain it. They have only asked for permission to build a memorial in an appropriate place, "Veterans Memorial Park."

The reason it has been refused (to me it is no reason at all) "Veterans Park was dedicated to all Veterans; we can't have special groups putting up memorials or others may want to build." So be it! If others are interested in working and raising money for a memorial, let there be monuments in Veterans Memorial Park!

I am sure the baseball players and the winter sledders wouldn't mind sharing some space with memorials dedicated to the people whom have gone to war to fight for our way of life.

I would like to respond to a letter which appeared in the Reader's Viewpoint last week. It was very nice of him to defend his mother's (the Chairperson) position. I will never be able to enjoy my son defending me again, as he was killed in Vietnam in defense of all of us Americans. He was 20 years old.

You say you were a spectator at the Parks Advisory

Commission meeting and was impressed with the dignity, compassion, respect, etc., at that meeting. What I saw was very different from your view. I don't intend to lump everyone in the same category as the Acting Chairperson, whom was very rude to Mr. Adam Banner when he asked to read a letter from Mayor Jernigan. The Acting Chairperson said in effect "they would deal with the issue as the Chairperson (ed.) would expect.

It was announced that only one person from the Vietnam Veterans Memorial Committee would be allowed to speak. The meeting was late starting. While Mr. Kinzinger was presenting his case and answering point by point every issue that had been raised by the commission, it seemed to me that the acting chairperson was mentally humming and snapping his fingers; at some time the chair told a long rambling story that if there was a point to it even the teller seemed to have forgotten by the end. It may have been to KILL TIME until the LATE TIE BREAKING VOTER ARRIVED, who then CAST his NO VOTE WITHOUT **HEARING** the presentation from the Vietnam Veterans Committee. IS THIS WHAT IS CALLED DIGNITY, COMPASSION and RESPECT?

In conclusion, I still do not have a reasonable answer for all the people who have asked me "WHY A PLOT OF GROUND IN VETERANS MEMORIAL PARK HAS BEEN DENIED Charlie Brown and all his fellow brothers" by the Ann Arbor Parks Advisory Commission. (Signed) Lois W. Brown Mrs. Della McIntire, Ann Arborite and Walter McIntire's mother, was another strong supporter of

our Washtenaw County Memorial committee. She was a lady with great passion for what we were trying to do. (With her umbrella in hand, WWII acting chairman, Mr. Sexton, after his negative deciding vote, almost found out how passionate she was.) In a letter to the Parks Advisory Committee, she wrote, At the age of 22 our son lost his life in Vietnam. We are writing to let you know we support the Vietnam Veterans in building the Memorial to honor all young men who, when their lives were just beginning, lost it for their country. Let's not forget them. We never will!

The following is another related letter written by Ann Arborites Mr. Dayle and Mrs. Grace McKenzie, parents of Ann Arbor U.S. Marine David Dayle McKenzie killed July 12, 1965. The McKenzies were also very strong supporters of our Memorial.

To: Ann Arbor Parks Advisory Commission From: Dayle and Grace McKenzie July 16, 1990 I am writing as a wife of a World War II Veteran who was a Prisoner of War in Germany in 1945. A son was born when he was missing in action. That son, a Marine twenty years later died in Viet Nam, July 12, 1965. For many years no one wanted to even mention this strange place let alone talk about a Memorial for these young men who could have ran off to Canada - lived a nice normal life. A Memorial would not only

remember our son but would help all the young men who survived the shame of fighting for their country where most people couldn't find on a map.

We need this Memorial in plain view - Remind everyone what all these young men - dead and even more important the living - tried to do. We have all failed in all these years to help the survivors. My husband and I want all of these men to know we care! We want to remember Viet Nam! (Signed) Dayle F. McKenzie and Grace F. McKenzie The following letter is from the Army Chief of Staff. It was written on April 27, 1967, to Joyce Mosier, the young wife of Ann Arbor soldier Clive Mosier. It expresses the Army's sincere respect and feelings for his and her sacrifice. It shows much more compassion than the anti-war demonstrators back then, and the Ann Arbor Parks Advisory Commission rejection. "Dear Mrs. Mosier:

It was with sadness that I learned of the passing of your husband, Private First Class Clive V. Mosier, on 24 April, in Vietnam.

I know that the loss of a loved one is one of the most difficult things a person has to face, but perhaps you may find some measure of comfort in knowing that he served his God and his Nation with courage and honor at a time of great need.

The memory of his service will be treasured by a grateful Nation because he has joined the long line of American soldiers who in times of national peril have given their lives for freedom and for peace. In Vietnam today, as on other fields in earlier days, we are defending the right of men to choose their own destiny, the right of men to live in dignity and freedom.

You can cherish the thought that your husband was noble in giving his life to safeguard these blessings for his loved ones and his Nation.

On behalf of the United States Army, I express heartfelt sympathy to you.

Most sincerely,

Harold K. Johnson, General, Chief of Staff of the United States Army." Not much more could have been said at the time to the wife of a soldier killed-in-action. Then many years later showing virtually no compassion, the Parks Advisory Committee voted against recognizing his sacrifice in a small part of Veterans Memorial Park. After the Ann Arbor Parks Advisory Commission denied our request, our committee was approached with several offers to locate our Memorial at other locations around the county. County Commissioner Roy Smith even offered us property to develop a park of our own in Ypsilanti Township. Our committee discussed and investigated all the offers.

A couple weeks after the rejection by the Parks Commission and no response from the Ann Arbor City Council, we met with Ypsilanti Township Supervisor, Wes Prater. He made a wonderful offer our Committee had to consider. At the next Ypsilanti Township Board meeting, our Committee presented the same request we did in Ann Arbor. We requested to have our Memorial located at the Ypsilanti Township Civic Center. At the end of our presentation, every person in attendance gave our Memorial committee a loud long standing ovation. Our Memorial was unanimously greeted with a tremendous "Red, White and Blue Welcome Home" by Ypsilanti Township Board officers and everyone in attendance. The

contrast between the Ypsilanti
Township reception and that of
the Ann Arbor Parks Commission
could not have been greater. Thank
you Ypsilanti Township!
The Township officers and
trustees included: Wesley Prater,
J.D. Hall, Ethel Howard, Ruth Ann
Jamnick, David Ostrowski, Karen
Lovejoy-Roe, and Brenda Stumbo.
The memory of that moment will
live forever in the hearts of our
Committee members and everyone
who was in attendance.

Ypsilanti Press reporter Jim Kise in his October 17, 1990 article wrote, "Ann Arbor's loss is Ypsilanti Township's gain, one official said, in the form of a Vietnam Veterans Memorial officially approved by the Board of Trustees Tuesday night." He continues, "Applause broke out three times during the emotional presentation of an artist's rendition of the memorial to the Township officials."

Ypsilanti Township gave us a 99year lease to the property around the Memorial on the Township grounds. From that moment on our Committee did not look back. THE END
