## Last Man Standing?

Just as an aside, it has been said that the last man standing is probably going to be a woman. By the time you read this, I'll have returned from the Vietnam



Veterans Leadership Conference in Palm Springs, California. One of the hot items on the docket will be the reports from two work groups that were tasked with helping us understand what it will take to transition through the last official days of "Vietnam Veterans of America."

In fact, many local veterans organizations, including some VVA chapters, are struggling because the increasing average age of the active membership. As that trend goes, so does the ability to be active and do hard work; so, organizations are finding it more difficult to keep doing the events and activities they have done in the past. This is causing National VVA to think about its responsibilities to those who expect VVA to carry on that work. There are two schools of thought:

First, we are Vietnam-Era Veterans. When we have all died, our work will be complete, and we hope somebody turns the lights off.

Second, we are Vietnam-Era Veterans. We were treated poorly, not considered combat veterans, and not welcomed by then-existing veterans' organizations. We also saw that something similar happened to the Korean War veterans. So VVA built a new organization, whose founding principle states the following:

"Never again will one generation of veterans abandon another."

VVA knows what returning veterans face. We have been through it before, and we know that, despite all the rhetoric, returning veterans will face



major problems. VVA will be here for as long as it takes to make sure Veterans receive the care and respect they have earned.

Because that work is not yet done, the work must be transitioned to a new group of people, who will continue to work according this founding principle.

Workgroup One will report on a plan for an orderly end to the Vietnam Veterans of America. They are concerned with everything, from making sure somebody does turn out the lights, to telling us when we need to stop taking new claims cases, when to stop appealing old ones, when to wind down

our fundraising projects and to figuring out how to decide what to do with all the physical and financial property that will be left when the organization is officially dissolved.

**Workgroup Two** is focused on a smooth handoff of the VVA mission, principles, and property to individuals who will pick up where we leave off. They are looking at such things as admitting non-Vietnam members to VVA, or passing the baton to AVVA, or passing the baton to another existing organization, or building a new organization to receive our mission and resources.

The reports will be preliminary. No action will be taken until the 2019 convention.

I am in with those who think we should find and train our replacements. We know the default position is to do little for veterans, especially considering how little veterans advocate for themselves.

For example, it was Vietnam Veterans who complained to Congress and VHA about "Gulf War Syndrome." We saw it first, because we knew to look for it due to our experience with Agent Orange. Many Gulf War veterans needed us to help them see the problem and the ways to address the problem.

At the Leadership Conference, I expect many people will advocate for the VVA to stop leading. I don't get that, but that's the problem with deciding before you hear all the facts. I will do my best to bring back an accurate version of both sides of the story. I will then pass the buck to you.

How will you want the Chapter to vote when the issue comes up at a future convention? It is your call. Your elected re-presentative will vote the way you tell them to.

On another note, two VVA 310 events are coming up, and the people who are organizing them need your help. The Heritage Festival is 24 through 26 August. They will need help with setting up, sales, and tearing down. Please contact Larry St. Antoine for details. Also, Pig Roast organizers need to sell a lot of raffle tickets during the festival. Please contact Don Miller to



help.

Then, the Pig Roast is going to be 9 September. It will take lots of work. Before the event. Don Miller and Al Dyer are gathering auction items, putting flyers, finding sponsors, buying supplies, etc. Please contact them to help. Then there is the all-night cooking crew. Please sign up to take a two-hour shift, if you can. Merchandise will need help setting up, selling and taking down. Then, after the event, Don and Al would like help to tear down, put stuff away and clean up.

What event do you want VVA 310 to attend or to produce in the coming years? Do you want

# **KIA's August**

#### **Anniversaries**

Lance Corporal Kendal Lee Benney, Jr. was born on February



22, 1948 to Mr. and Mrs. Kendal L. Benney of Ypsilanti. Kendal lived with his father and step-mother in Big Rapids, Michigan until

September of 1965, where he attended Ypsilanti High School. He left school during his Junior year and enlisted in the Marine Corps in March of 1966. Lance Corporal Benney began his tour of duty in Quang Nam Province, South Vietnam, in December of 1966 serving with the First Marine Division as a machine gunner. Kendal was killed on August 20, 1967 while standing watch, when he suffered multiple fragmentation wounds from a bomb. Lance Corporal Benney is survived by his mother, father, step-mother, two sisters, and one brother, who was serving in South Vietnam when Kendal

was killed. Kendal's brother was discharged from the Army and escorted his brother back to the "World" for internment. Kendal lived 19 years, 5 months and 28 days. He is resting in the Altona Cemetery in Altona, Michigan. Kendal's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 25E Line 018.

Private First Class James William Davis was born on March 24, 1947 in Erie, Pennsylvannia, to Mr. and Mrs. William A. and Gretchen Raub Davis. James is a 1965 graduate of Belleville High School, where he lettered in football and swimming. James attended Michigan State



University and Cleary College. James entered the Marine Corps on December 13, 1968. He began his tour of duty in

Quang Nam Province, South Vietnam, on July 7, 1969 serving as a rifleman with the 1st Marine Division. James was killed on August 13, 1969 as a result of small arms fire just one month and six days into his tour of duty "In-Country". James William Davis is survived by his wife, a son, his parents, and two brothers. He lived 22 years,

4 months and 10 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan and his name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 19W Line 029.

### **VVA: What's Next?**

VVA chapters have voted on several occasions not to admit veterans of other eras. With those votes, two things eventually happens:

- 1) Recognizing that membership is getting older and is less able to take on the workload it used to, pick a date upon which to dissolve the corporation in an orderly manner and redistribute the assets as we see fit; or,
- 2) Let the State of New York



decide who gets our assets and when we dissolve after somebody files a complaint because we failed to do a clear legal duty.

That question was raised again at the leadership conference I just attended in Palm Springs. But what about our commitment that "Never again should one generation of veterans abandon

another?" Are we going to abandon future generations in violation of our own principle? Not if National's current idea is workable and is approved by membership.

Now that I've had both briefings, let me tell you what I learned about VVA's strategic planning Workgroups One and Two. As I now understand it, Workgroup One assumes that we don't want the State of New York to get to decide who gets VVA National's property when the lights are turned out. To avoid that, a strategic plan must be developed that will provide for an orderly shutdown and transfer of



assets.

Workgroup Two is working on another part of a long-term strategic plan. Their mission assumes that the creed "Never again will one generation of veterans abandon another" is both a creed that deserves to be handed down to later generations

of veterans and a legacy that is an essential part of VVA National's identity. Workgroup Two believes that it is important that future generations know what VVA has accomplished. Therefore, Workgroup Two is developing a strategic plan that has identified our main legacy impacts and that proposes to carry on each piece of that work one way or another, and that preserves the memory of the work done so far. The legacy areas that Workgroup identified for us are as follows:

- 1) VVA is the only organization that uses litigation to keep Congress and the Executive Branch on mission, with a 70% win ratio.
- 2) We are the premier veterans organization that advises Congress on legislative issues effectively enough to impact ultimate legislation.
- 3) We are the premier veterans organization that advocates for veterans before the VBA and VHA, processing claims and helping VBA and VHA understand the veterans' situation, making better choices about what merits compensation and which claims are viable and which are not.
- 4) We are the premier veteran support organization, including agent orange, burn pits, and irradiated ammunition, and even food pantry and other direct supports. In addition to scholarships and money to charities, we engage in direct service to veterans wherever we find them.
- 5) The ongoing funding program.

Workgroup Two's present idea focuses on a two-step process of finding, training, equipping,



empowering the next and generations of veterans, while preserving the public's memory of what VVA has done till now. Workgroup Two proposes to start a 501(c)(3) foundation, with a suggested name of Vietnam Veterans of America Legacy Foundation (VVALF), to act as our agent for the development of the next organization run by the next generations of veterans. Thus, VVA will meet with nextgeneration veterans across the nation to let them know what VVA does and to encourage them to produce comparable results going forward. For those who wish to pick up where we leave off, the foundation will help start a new 501(c)(19)organization with a broad goal of producing the same results the VVA did. as in the five legacy areas mentioned above. The foundation will then provide training, economic support, mentorship, and institutional learning for the new organization. It is good to remember that,

when we started to build VVA. there were groups trying to something for Vietnam Veterans, but they were not doing it together. They were fighting with one another more than fighting evil or fighting for justice. Also, back then, Vietnam veterans largely did not trust the prior generations of veterans to lead us because those veterans didn't seem to know about our issues, or to be interested in helping us deal with those issues. we were somewhat rebellious and untrusting. These newest generations of veterans have similar trust issues and



similar organizing problems. We hope they will recognize our success and will decide that it would be good to learn these lessons from us, rather than having their own 20-year startup learning curve.

The other thing that VVALF will do is to preserve our legacy, ensuring the following generations of veterans and civilians will remember that there once was a VVA, which turned things around for at least three generations of warriors and servicemembers and their



loved ones.

Helping the next generations of veterans extend that legacy and continuing to do our good work will go a long way toward preserving that legacy. Also, the foundation will look at how schools teach Vietnam War history and how museums show art related to the Vietnam War, making sure old Vietnam Veterans do not fade away, so that the same mistakes do not happen again.

The Work Groups should work together. If Workgroup Two is successful and a new Veterans organization picks up where we leave off, Workgroup One's work will also be necessary. One way or the other, VVA National will be dissolved.

I look forward to your questions and discussions. The participants at the leadership conference had plenty of questions still to be addressed. For example, VVA 310 is its own legal entity. The workgroups do not know what will happen if our chapter decides we can last

longer than National. Do we need to find our own replacements? Do we have to wait 8 to 12 years to turn out the lights or can we retire sooner? These are questions that our own Board of Directors will need to address as it develops our Chapter's long-term strategic plan.

## Freedom is Not Free Part Two

I went to visit my parents after the reunion and asked my mom about me being "almost" left behind. Still after 30 years, she burst out in tears and apologized that she didn't mean to leave me behind. She thought my older sister was dead, rushed to get her, while inadvertently leaving



me behind. My older sister also survived the trip, despite being trampled on.

During our 30th anniversary, the local newspaper published a story on my family's escape. A gentleman in San Francisco contacted the editor to seek permission to speak to my father.

He wanted my dad to know that he had in his possession my dad's flight suit and those of the rest of the crew. He told my father that his dad had served and was responsible for bringing my family and others over to the United States.

His dad had passed away, and for some reason, the son had decided to safeguard his dad's. When he read the story in the paper, he knew he wanted to give it back. He asked for my dad's address and sent the suit back to him, without asking for anything in return. When my dad received his flight suit, I had never seen him so happy. He was beaming with joy. As he pulled the flight suit out of the box, it looked to me like something my 12-vearold son would wear. It was a moment to savor.

Why am I here today, telling you the story? I am doing this for several reasons. First, I want to ask those who have served in the Vietnam War for your forgiveness. I spent most my life living in ignorance, living a lie. When I saw a Vietnam veteran. I would avoid that person. I felt a sense of guilt that you fought in a war for which we were to blame. I was ungrateful for your sacrifice, including the ultimate sacrifice of the 58,220, who lost their lives for my family's freedom and the freedom of many others.

I enjoyed my personal freedom and took it for granted. I was selfish and foolish in my thinking. Let's say that I once was lost, but now I am found. With the help of Jesus, my Lord and Savior, he helped me find my way home. He reminded me of where I came from, and the sacrifices it took to literally buy the freedom that my family and many others have today.

In the past few months, I found my way to the Vietnam Veterans of America Charles S. Kettles Chapter 310 in Ann Arbor. When I reached out to them, intending to thank them for what they their lives for their brothers and sisters, even if they were strangers in a strange land, like my family.

Second, I want to thank you for serving in our war and for continuing to defend freedom now and in the future. My family, like many other families, escaped from Vietnam, not only



had done for me and my family, they welcomed me with open arms. I met a group of men and women who are passionate and committed in serving others, just as they did 40 to 50 years ago. Not only was my family blessed back then, I am blessed now, seeing what it truly means to serve.

A Bible verse I have tried to incorporate into my life reads as follows: "This is how we know what love is: Jesus Christ laid down his life for us. And we ought to lay down our lives for our brothers and sisters" (1 John 3:16). When I reflect on Memorial Day, I see that there are plenty of people who have sacrificed

to flee from war and find safety, but also because we knew our personal freedoms would have been forcefully taken away from us. The more than 50 people who boarded the plane with my father on April 3, 1975 were not unaware of the risks. They had no idea where they were going. except that it was anywhere else but there. My family left one of the most beautiful countries on this earth, taking nothing but the clothes on their backs, to avoid being under Communist rule. What does that rule look like? There is no family structure; the government is your family. There is no freedom of religion: what government tells you is your religion. If you don't agree with these ideals, they take you in front of your family and shoot you in the head.

That, my friends, is why my dad was willing to do everything he could, for us to have a better life—and that better life is right here, right now in the United States.

As I finish here today, I want to honor our fallen and acknowledge our veterans by showing my appreciation and gratitude for buying my family's freedom. Allow me to shake your hand, give you a hug, thank you, and even pray for you if you wish. God Bless America and our troops, and Thank You!
