### President's Message:

On May 5<sup>th</sup> and 6<sup>th</sup> Jon Luker and I attended the Region 5 Conference in Columbus, Ohio representing our Chapter as delegates to the 2017 National Conference, which will be held on August 8 – 12. Other representatives from our Chapter were my wife, as a delegate for AVVA; Ken Rogge, representing Michigan State Council as Vice-President and as Chapter delegate to National; and Sandie



Wilson, Chapter delegate to National, representing the National Health Care Committee Chair. Opening remarks were made by Tom Burke, Region 5 Director. Cecilia Essenmacher, Region 5 AVVA Director; Cliff Riley, Buckeye State Council President and host of the event, John Rowan, National President; and, Sharon Hobbs, National AVVA President also made interesting presentations.



The heart of the Conference was to prepare for the upcoming National Conference in New Orleans. There we will be voting for the National Officers, National Board of Directors, and Regional Board of Directors. There will also be voting on National Constitutional Amendments and Convention Resolutions. I have placed links to each of these topics on the front page of our Chapter website in the Newsflash section. As you can see when you follow the link to the

National Officers and the two Boards of Directors, there is no competition for the current Officers. The National Board of Directors is a totally different story. Nine Board members are allowed at National. Currently there are eighteen nominees. As far as Regional Board of Directors, there are four Regions that will need decisions made. Our Regional Director is running unopposed.

We heard from guest speaker Ashley Lester who is a representative from the Columbus Downtown Development Corp. She gave a presentation (with slides) for the 50,000 square foot National Veterans Memorial and

Museum being built in downtown Columbus. Construction is already in progress and is expected to open next summer. It is the only national museum in the U.S. dedicated strictly to Veterans. Please visit their





website (<a href="http://www.nationalvmm.org">http://www.nationalvmm.org</a>) and look not only at the conceptual pictures, but also look at the in-progress photos. Here's a quote from their website describing the exhibits:

"The exhibit designer, Ralph Appelbaum Associates, is working to create an exhibition that presents a narrative journey evoking the core themes and stories of the veteran experience. The interpretive framework for the exhibits is based on four central pillars: Honor, Connect, Inspire, and Educate. It will honor the historical and contemporary examples of veterans' stories. Rather than focusing exclusively on war, combat, or the military, this exhibition narrative explores the transformative experience of military service while connecting it to the broader idea of public and community service. Further, it hopes to stimulate an ongoing dialogue in an effort to increase connections between civilians and veterans.

To accomplish these goals, the exhibition features a set of Thematic Alcoves evoking the emotions and challenges of those who have served the nation and a dimensional Timeline telling a chronological story of the major events and people who have shaped our military history. Additional emphasis is being placed on developing links between exhibition content and educational curriculum so that the National Veterans Memorial & Museum may be used by educators as a tool to bring content to life both on site and remotely via distance learning modules."

We heard from several of the National candidates for office including our own Sandie Wilson. John Rowan spoke as a candidate for President; Marsha Four, running for Vice-President; Bill Meeks for Secretary; Joseph Jennings II, who is running for Director At Large, who is also currently National Service Officer; Dave Simmons, Director At Large, who also works with Veterans Against Drugs, and Tom Burke, running for Region 5 Director, who also works with Veterans Benefits.



The Banquet was nice. We had previously selected our main dish of either salmon or chicken. I had the chicken and my wife had the salmon. We both thought the meal was very delicious as did the others at our table.

As conferences go, this one was not too bad. The hotel staff was great and very attentive to our needs, and the restaurant food was terrific. It was interesting watching the chef prepare five breakfast egg dishes at once. Very professional.

Over the next few months, in our monthly general meetings, we will

Back in 2003, members of VVA 310 began packing boxes in the Kinzinger's living room for our troops in Iraq and Afghanistan. Since then we have mailed 3,975 packages to military personnel overseas. The cost of the postage to mail them has exceeded \$60,000 which has been paid by loyal donors and additional fundraising.

On Sunday, June 11<sup>th</sup>, at 3 p.m., we will begin our next packing party at the Ann Arbor VFW Post at 3230 S. Wagner Road. If you are bringing items for the packages, please be there at 2:30. We will begin with a prayer at 3pm. We will reach a milestone that day when we pack box number 4,000!

If you would like to help, come out and pack with us. If you would like to bring morale building personal letters or notes to put in the packages, please do that also. We do pack special packages for females too. If you would like to bring items to put in the packages, I would suggest CDs, DVDs, individual snack foods, magazines (not more than 60 days old), nuts, hand sanitizer, socks, bandanas, etc.

We have a potluck meal afterwards, so please remember that too. Bring your favorite dish to share and enjoy breaking bread with us.

We have attorney Elmer White who is again willing to match up to \$500 at the packing party for postage cost. Please remember that too.

We would be surprised at how many service personnel we have touched over all these years and packages. We continue to live our Chapter motto.

From now through evermore."



### New Flag Stands

Thanks to George Perrault and several people he convinced to help out with the project, including VFW Post 423, there are three new sets of flag stands, five new flags and two recovered flags.



This first pictures shows the six flags that will flank VVA 310 officers during future meetings. From left to right, they are: The US flag, The State of Michigan flag, The POW/MIA flag, the Agent Orange Flag, The Associate Vietnam Veterans of America flag and, finally, the Vietnam Veterans of America flag.

The Agent Orange flag and the two new flag stands were donated by Home Services of America. George Sondergeld was the craftsman who built them. These six flags have all new tops thanks to an anonymous donor.



This second picture shows five new service flags, seven new tops and a cleverly designed new, portable flag stand. The stand folds in the middle so it can fit in a car. This full display is available for use by VFW 423 and VVA 310 as both units contributed funds for its development.

Again, the flags and new tops came from an anonymous donor. The flag stand was donated by Milan Die Casting Company and was crafted by Vic Diehr.

The businesses and craftsman were presented with a Chapter Challenge Coin and thank-you letters.

### More Than Names On the Wall

June is the month of new beginnings and different assignments. Couples are getting married. Students are enjoying summer vacation. Recent graduates are starting jobs for which they have prepared or are taking other jobs until openings occur or opportunities arise in their field of interest. The summer months are also when the most babies are born, so there are new infants to be cared for and loved.

That brings us to the focus of this month for the 76 young men on our Vietnam Memorial. How many were married? 28 men (40%) were married; 48

(60%) were single. How many had children or maybe one on the way? There were 25 children left behind by the 17 who had children. What were their assignments or jobs as they were sent to Vietnam?

Pete Belaire researched the MOS of these 76. It is interesting to note the range of jobs for which they received specific training and



to which they were officially assigned. The most prevalent job specification was Infantryman (Army) and Rifleman (Marine) which was listed for 35 of the servicemen. Recognizable specialties were: Hospital Corpsman/Medic (5), Helicopter Pilot and Helicopter Maintenance and Repair (5), Skyraider A-1H Pilot (3), Fixed-Wing Spotter Pilot (1), Heavy Bomber Pilot (2), Military Police (1), Armor Reconnaissance Specialist (1), Antitank Assaultman (2), Radio-Teletype Operator (2), Antenna Installer Specialist (1), Wire Systems Installer (1), Combat River Boat Patrol (1), Food Service Specialist (1), Tactical Intelligence Staff Officer (1), Cannon Fire Direction Specialist or Officer (2), Fire Protection Specialist (1), Field Artillery Cannoneer (1), and Heavy Construction Equipment Operator and Instructor (1).

Regardless of their specific assignments, some of them were filling in or covering for another or volunteering for something outside of their specialty when they were killed.

It took a "team," and every man did his job to support each other and to maintain safety of all. All jobs were important and critical to the mission. While some died fulfilling their assignment, others died while performing outside their MOS or from accidental injury or illness. The testimony of men who served with them supports the fact that these men performed their duties and, in many cases, saved others from being killed. They are forever remembered for their selfless courage.

### JUNE'S KIA'S - MAY WE NEVER FORGET

Lance Corporal Larry James Eglinsdoerfer was born on April 8, 1948 to Mr. and Mrs. Edward J. Eglinsdoerfer. Larry is a 1966 graduate of Milan High School located in Milan, Michigan. He was employed by Ford Motor Company at the Saline Plant in Saline, Michigan when he entered the Marine Corps on April 16, 1968.

Lance Corporal Eglinsdoerfer began his tour of duty in An Hoa, Quang Nam Province, South Vietnam on October 5, 1968 serving as an Antitank Assaultman

with F Company, 2nd Battalion, 5th Marines, 1st Marine Division. According to a posting by Private First Class Michael Ryan:

"Eggy had 3 days left. A Sergeant came in the tent and asked for a volunteer to go to the 1st Battalion, 5th Marines bunker line. Eggy said, 'I'm too short! I had just got back from the hospital...second Purple Heart. When the Sergeant convinced Eggy I wasn't in shape for it, Eggy agreed to go. After the Sergeant left I said, 'I'll go Eggy'. He looked at me, for the last time and said, peacefully, 'No, I'll go Ryan'. Four hours later he was dead. Once when we hadn't been supplied with food for a while, Eggy shared a tin of jelly with me. Thank you for my life Eggy. Semper Fi!"

Larry was killed on June 7, 1969 when an enemy rocket hit his bunker. Larry James Eglinsdoerfer is survived by his parents, three brothers and four sisters. He lived for 21 years, 1 month and 29 days. He is resting in the York Township Cemetery near his home in Milan, Michigan. Larry's name is listed

on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial located in Washington, DC on Panel 23W Line 099.

Specialist 4th Class **H. Neil Stehle** was born on March 30, 1945 to Mr. and Mrs. Herbert H. Stehle in Ann Arbor. Neil is a 1963 graduate of Ann Arbor High School where he was on the gymnastics team. He attended Eastern Michigan University majoring in psychology prior to entering the United States Army on April 29, 1967.





Specialist 4 H. Neil Stehle completed his basic training, and radio and communications courses at Fort Knox, Kentucky. He went to Fort Benning, Georgia where he received training at the paratrooper school. Neil was sent to Vietnam on December 13, 1967 where he was assigned to B Company, First Battalion, 503rd Infantry, of the 101st Airborne Division. On June 3, 1968, Specialist 4 Stehle was serving in Thua Thien Province in South Vietnam when he was wounded by small arms fire. Neil was transported to a hospital in Japan where he died of his wounds on June 11, 1968. He lived 23 years, 2 months and 11 days.

H. Neil Stehle is resting in Washtenong Cemetery in Ann Arbor. He is survived by his parents and two sisters including seven nieces and nephews. Neil is listed under Ann Arbor on the Ypsilanti Township Vietnam Memorial and is located on Panel 58W Line 027 on the Vietnam Memorial in Washington, DC.



Private First Class **James Herbert Covey** was born on August 3, 1949 is the son of Herbert H. and Patty Sue Tate Covey. James is a 1968 graduate of Ypsilanti High School located in Ypsilanti, Michigan. He worked at the Ypsilanti Public Library for two years since he was 16 years of age.

Private First Class Covey began his tour of duty near Da Nang, Quang Nam Province, South Vietnam on June 3, 1969 serving with K Company, 3rd Battalion, 1st Marines, 1st Marine Division, III Marine Amphibious Forces as a rifleman. James was killed on the evening of June 21,

1969 as a result of an explosion from a Rocket Propelled Grenade (RPG) after being "In-Country" for 18 days.

James Herbert Covey is survived by his mother and father. He lived for 19 years, 10 months and 18 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. James' name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 22W Line 103.

Major Frank Rudolph Maki was born on March 13, 1928 in Rudyard, Michigan to Mr. Victor and Mrs. Lemple Ann Maki. Frank graduated from Rudyard High School before enlisting in the Army in 1946 where he completed his Basic Training at Fort Lee, Virginia. He took part in the Berlin Airlift serving at the Rhein Main Air Base as an Air Ground Liaison NCO. He returned from Germany and spent some time as a civilian before returning to the Army in 1950 where he served with



the 7th Infantry Division in Korea as a rifle and weapons squad leader. Sergeant Maki accepted a reserve commission as a Second Lieutenant while



serving in the Korean War. He continued to serve in the Regular Army as an NCO, as he was promoted as a reserve officer. Since Korea, Frank served with the 821st Engineer Aviation Battalion at Fort Leonard Wood, Missouri then serving with the 820th Engineer Aviation Battalion at Michigan State University as a military science instructor. According to the Battalion History of the Army ROTC Battalion at Eastern Michigan University, "in 1961, he taught ROTC at Eastern Michigan University for four years, where he led the rifle team to the championship and served as an advisor to Arm of Honor Fraternity. During this time, he accepted his promotion to Captain even though he was rated number one on the list to be promoted to Sergeant Major. He then served as a Company Commander at Fort McClellan where his troops would earn four consecutive Best Company awards."

Major Maki began his tour of duty in Quang Tri Province, South Vietnam on May 7, 1971 serving as an Advisor, Advisor Team 3, Headquarters, Military Assistance Command Vietnam (MACV) Advisors. Captain Maki was killed in action at Fire Support Base Fuller in Quang Tri Province while coordinating medical aid to wounded soldiers on June 22, 1971 during his third tour in Vietnam. He was then posthumously promoted to Major.

Frank Rudolph Maki is survived by his wife, son, two daughters, his father, two sisters and two brothers. He lived 43 years, 3 months and 9 days. He is resting in Highland Cemetery in Ypsilanti, Michigan. Frank's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 03W Line 086.



Second Lieutenant **Philip Matt Crane II** was born on January 29, 1947 to Mrs. Howard P. Gragg and the late Philip M. Crane of Ypsilanti. Philip played the accordion when he was very small. He played Little League Baseball. Philip is a 1965 graduate of Ypsilanti High School where he played on the varsity tennis team, was a member of the varsity debate team, and a member of the National Honor Society. He worked all during High School and College at the A&P Store. He went on to attend the University of Michigan until he enlisted in the

Army on February 1, 1967. He completed Officer Candidate School at Fort Benning, Georgia.

Second Lieutenant Crane began his tour in Vinh Long Province, South Vietnam on May 14, 1968 serving as a Tactical Intelligence Staff Officer on Advisory Team 52, Headquarters, Military Assistance Command Vietnam (MACV).



Lieutenant Crane was flying in a helicopter as a special observer when a flare ignited inside the aircraft causing him to fall from the aircraft on June 26, 1968. He was "In-Country" for one month and 11 days.

Philip Matt Crane II is survived by his mother, his wife, and a sister. He lived 21 years, 4 months and 27 days. He is resting in Crestwood Memorial Gardens in Flint, Michigan. Philip's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 54W Line 002.


### Regular Meeting Minutes

### 11 May 2017

Call to order by President Draper at 1802

Pledge of Allegiance and moment of silence for POW/MIA's, their families and those who are serving in hazardous places around the world.

**Motion** to Approve the April Minutes, Moved by Draper, second by Wilson. Approved.

**President's Report:** Draper. WJR radio personality, Frank Beckman, interviewed LTC Kettles. There is a link to the interview on the Chapter website.

22 May is a Quartermania at Milan American Legion 268. Starts at 1830 but doors open at 1700. AVVA requests your help. It would be good to have 7 or 8 people.

Senator Rubio introduced a bill to make it easier to get rid of underperforming people at the VA. If you want to, there is a letter on the website that you can put your name on that will then go to your representatives.

### Good of the Order:

**Perrault:** There are new flags with new two-part poles with new eagles or spears on top. Each flag has its own bag for transporting the flag. If you move the flags, take them apart, use the bags, store them flat. There was a lot of work put into making the bags, so don't lose them.

Recently at our WACU board meeting, which included five VVA 310 members, we discussed a "hot" topic: how to best, a.k.a., the most efficient way, to help someone in trouble before they do something that

tears themselves and their caregivers apart.

It was brought up that ultimately they must become the captain of their own ship. That concept begged several questions to me, as I pondered the process. What procedures can be implemented to allow a person to actually see what is facing them in the mirror, without there being denial? How do we best come alongside the caregivers and family members to shore them up while this process continues to give them hope and coping mechanisms? What is our responsibility should our efforts fail and the person takes their own life or does something so radical as to warrant societal discipline?

There are some procedures in place (Veteran's Court, Bridge, VA assistance, WACU, and various veterans help lines), but, ultimately, it



involved our being active in the process. Sometimes that involvement leads us to frustrations much like the caregivers go through on a regular basis. That frustration is my focal point for this article.

Most of us have worked through a number of similar issues and have some experiences to help in our mentoring or coming alongside. But those experiences have also taught us that not all wounds heal with the passing of time; as Frodo Baggins said at the end of LOTR, The Return of the King, because they cut too deeply, like having limbs blown off, head injuries, or replaying a scene where a friend gave his life for us. They are life altering events that drastically change the status quo, and thus alter our norm – forever.

For me, I had a long road as I wrestled with the Lord and others to find a new norm. But I did eventually find it without having to have "answers" to all my questions. Granted, I had the advantage of theological training to speed the process, and even with that training, it took 11 years. My help came from the Psalms, through David who was also a warrior and leader of warriors and a nation. As he struggled he penned the following that I offer for your contemplation: Psalm 23 (which most are familiar with) through Psalm 25. The entire passage should be read together and thoroughly meditated upon.

Especially relevant is Psalm 25: 1-5:

"Unto you O Lord, do I lift up my soul [that which is ripped apart and bleeding]. O my God, I trust in you: let me not be ashamed, let not my enemies [wounds external and internal] triumph over me. ... Show me Your ways, O Lord; teach me Your paths. Lead me in Your truth, and teach me: for You are the God of my salvation: on you do I wait all the day."

Healing does not come quickly, but the wait is "well" worth the time it takes.
