AA VA Needs A

Different Kind of Help

Chapter members donate hundreds of thousands of dollars to the VA Ann Arbor Healthcare System by donating their time through VAVS. But we have been asked to help out in a different way that will have a direct impact on the care veterans receive by helping the staff better understand how to deal with us—to learn from our real world experience with them. The following is an article that explains the program and the dates for which the VA needs volunteers.

"Relationship Based Care (RBC) is new care model that engages staff at a higher level in their work, providing a foundation for both inspiration and education, focusing on three key relationships; caring for yourself, caring for your colleagues, which in turn allows for optimal care of Veterans and their families. Within this program, there is a three-day seminar called Re-Igniting the Spirit of Caring, that allows participants to gain increased awareness, reconnecting them to their common purpose, and reminding us why we chose healthcare. The purpose is renewing



empathy, compassion, and mutual respect in staff members of the VA. During the inspirational seminar, there is a panel of Veterans and/or family members invited to attend and share their experiences with the class, allowing staff to reflect on a situation either positive or negative.

It would take about an hour and a half and will include a dialogue between you and the staff that are attending. We will ask you to share a little bit about yourself (because your stories are what keep us passionate about working at the VA!) and then a Q&A session. You will be asked to remember a time at the VA where you had a positive moment of care, maybe it was in line getting a coffee, or when you or your loved one was admitted. Describe a single moment when you felt cared for. What made this a positive experience for you? What about the experience would you like to see repeated? By asking you "What went right?" we hope to gain insight in a positive manner that will allow us to replicate the good things that are happening.

The Re-Igniting the Spirit of Caring Panel have several openings taking place; Mar 30, Apr 16, June 15, and July 27.

All of our classes start at 1245 and go to 2 pm. I meet you at the ER entrance and bring you to the classroom.

If you would like to participate in one of our Panels, please contact me to choose which date or dates best fits in with your schedule.

Thank-You in advance for helping us to stay focused on our RBC mission of honorably serving those that have served."

Private First Class Lavern Michael Lamey was born on November 7, 1949 to Mr. and Mrs. Ralph J. Lamey of Milan, Michigan. Lavern is a 1967 graduate of Lincoln Consolidated High School. He entered the Army on July 18, 1967 receiving his Basic Training at Fort Knox, Kentucky. He completed his Advanced Training at Fort Polk, Louisiana.



Private First Class Lamey began his tour of duty in Dak To, Kontum Province, South Vietnam on December 16, 1968 serving as a Grader Operator with the 15th Engineering Company, 299th Engineering Battalion, 937th Engineering Group, 18th Engineering Brigade. Lavern was killed by enemy mortar fire on March 5, 1969.

Lavern Michael Lamey is survived by his parents, his wife, a brother and two sisters. He lived 19 years, 3 months and 28 days. He is resting in Marble Park Cemetery in Milan, Michigan. Lavern's name is listed on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 30W Line 047.



Corporal **Gregory Randall Shambaugh** was born on October 2, 1947 in Ann Arbor, Michigan to Mr. Robert Shambaugh of Toledo, Ohio and Mrs. Geraldine Shambaugh of Ann Arbor, Michigan. Gregory attended Carpenter School, Tappan Junior High School and Ann Arbor High School. He went on to graduate in 1966 from Howe Military School in Howe, Indiana. Gregory attended Eastern Michigan University in Ypsilanti, Michigan before enlisting in the Army on January 19, 1967.

Corporal Shambaugh began his tour of duty in Thua Thien Province, South Vietnam serving as an infantryman with D Company, 1st Battalion, 502nd Infantry, 101st Airborne Division. According to First Lieutenant

McLemore, in a letter to Mrs. Shambaugh, "On March 6, 1968, while Gregory was participating in a search and destroy mission with Company D, 1st Battalion, 502nd Infantry, he was struck by an enemy bullet and instantly killed." The Bronze Star Medal was posthumously presented to Mrs. Shambaugh.

Gregory Randall Shambaugh is survived by his parents and his wife. He lived 20 years, 5 months and 4 days. He is resting in Arborcrest Cemetery in Ann Arbor, Michigan. Gregory's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 43E Line 034.

Specialist 4 **Earl Thomas Hoag** was born on March 9, 1948 in Detroit, Michigan to Mr. Robert and Mrs. Mary Hoag of Ypsilanti, Michigan. Earl is a 1966 graduate of East Tawas High School in East Tawas, Michigan. He also attended Alpena Junior College and Cleary College. Earl worked for United Air Lines as a flight food handler at Detroit Metropolitan Airport.

Specialist 4 Hoag entered the Army on April 20, 1968, completing his Basic Training at Fort Ord, California and Advanced Training at Fort Polk, Louisiana. He began his tour of duty in Thua Thien Province, South Vietnam on August 19, 1968 serving as an infantryman with B Company, 2nd Battalion, 502nd Infantry, 101st Airborne



Division. Earl was killed when his patrol was ambushed and he sustained



multiple fragmentation wounds on March 8, 1969. He died just one day before his 21st Birthday.

Earl Thomas Hoag is survived by his parents and three brothers. He lived 20 years, 11 months and 29 days. He is resting in Grand Lawn Cemetery in Detroit, Michigan. Earl's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 30W Line 076.



Corporal Jack Maynard Hopkins was born on April 11, 1944 in Grand Rapids, Michigan to Mr. and Mrs. Charles X. Hopkins of Ypsilanti, Michigan. Jack is a 1963 graduate of Ypsilanti High School. He enlisted in the Marine Corps in July of 1963. He began his tour of duty in Thua Thien Province, South Vietnam in April of 1965 serving as a Field Artillery Cannoneer with K Battery, 4th Battalion, 12th Marines, 3rd Marine Division, III Marine Amphibious Forces.

Corporal Hopkins was severely wounded on February 27, 1966 when the jeep he was riding in detonated an enemy land mine. He was Med-Evac'd to Clark Air Force Base Hospital in the Philippines suffering from compound fractures of his right leg, multiple fractures of his left heel, and a cerebral concussion. Jack died of his wounds

on March 2, 1966.

Jack Maynard Hopkins is survived by his parents and a brother, Charles X. Hopkins, who is also serving in the Marine Corps in South Vietnam. He lived 21 years, 10 months and 21 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Jack's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 05E Line 095.

Private First Class **Frank Leslie Keck** was born on June 1, 1946. Frank attended Saline High School in Saline, Michigan for six years, returning to Kalkaska, Michigan after the death of his father in 1965. He would have been in the 1964 graduating class in Saline where he played varsity basketball. He worked in construction before entering the Army in June of 1968.

Private First Class Keck began his tour in Tay Ninh Province, South Vietnam on December 22, 1968 serving as an infantryman with C Company, 4th Battalion, 23rd



Infantry, 25th Infantry Division. He died as a result of enemy small arms fire on March 29, 1969.

Frank Leslie Keck is survived by his wife and son, his mother, and one brother. He lived 22 years, 9 months and 28 days. Frank's name is listed on the Vietnam Memorial in Ypsilanti Township under Saline. His name also appears on the Vietnam Memorial in Washington, DC on Panel 28W Line 082.


