



I enter the small sesquicentennial town, following the

Quiet track of sentinel flags leading me, like a recon platoon, to the

Grassy lawn and the glistening darkness of the Traveling Wall.

I seek out the Welcome tent, opening the black vinyl cover of the

Locater directory to begin my search. "Jesus," I murmur to the host

Attendant as I pour over the countless plastic pages, each with perhaps

One hundred names. "I am *alway*s" (my voice catches) "staggered by *how many* (and my voice catches again) are 58,000."

At the Wall, I find the names I seek. Leaning forward, I pull up my dog tags so That they swing free, grazing the inscriptions, their tinny sound A familiar kind of speaking,

As if pronouncing my name to those ranks and ranks silently inscribed . . .

From the driver side window I see a quiescent pond as the town Recedes, a basin of water lilies opening to the day, vivid with the same Color of growth and affirmation as green shoots spiking heavenward From far distant rice paddies, now so long ago.

About the author:

I joined the VVA perhaps three years ago at the same time that I joined the VFW and American Legion. Though I presently reside in southern Illinois (near St. Louis MO), I applied for membership in Chapter 310 because I am a native Ann Arborite, a 1963 graduate of Ann Arbor High School (now Pioneer), and a 1974 graduate of the University of Michigan Law School. After law school, I lived with my wife in Ann Arbor until 2009, and we raised both of our children in the community.

I am a high school classmate both of (Herbert) Neil Stehle and George Airey. When I visit the Vietnam Memorial in D.C. or drive to see the Traveling Wall when it tours in the region where I live, I make a point of seeking out the names of Neil and George, along with the names of others with whom I served in the military (U.S. Army, 1968-71). After visiting the Traveling Wall in the small town of Avidon, Illinois in June 2014, I wrote the attached poem. It is dedicated to Neil and George and also to Roy Stewart, a close friend and neighbor whom I met while he and I were both serving at Fort Sam Houston in San Antonio (my last duty station before completing my enlistment). Roy deployed to Vietnam in the early autumn of 1971 and died in a helicopter crash two days before Christmas, leaving a young wife and four-month old daughter.

One note about the poem. I refer in the text to a close friend, a Viet Nam combat veteran who later became a successful advertising writer focusing on the automotive industry. His name is Lawrence (Lawry) Dolph and he too is a native of Ann Arbor, currently resides in Ann Arbor, and is also a member of the AAHS Class of 1963. Lawry was awarded the Bronze Star for service in an infantry recon unit with the Ninth Infantry Division at Dong Tam.



The Sacrifice of Serving

The Vietnam Veteran Memorial in Washington D.C. is 246 feet and nine inches of solid gabbro rock. On that rock, 58,307 names are engraved. Tourists walk down the wall in remembrance of the many lives lost, the mass of names on the wall standing as a reminder of the sacrifice so many Americans have made. And although they are few, some don't go to see the numerous names on the wall, instead, they go to see only one.

Girls, who grew up never knowing their fathers, leave the roses from their wedding day, hoping that their daddy would be proud. Boys, whose only father figure was a picture on the wall, take their children to

the name of the man who sacrificed his life for them. As tourists pass by, they remember that he walked like that; that he always wore his shirt like that; that he hated when people laughed like that.

The men on that wall, along with more than a million others from previous and latter battles, paid the ultimate sacrifice for their country; but, they aren't the only ones who paid the price for freedom. For every one of the thousands upon thousands of men and women who have died in the service of our country, there is at least one person who lost a part of themselves in the heartbreak of the news of their death: at least one person who received a simple flag and a "thank you" that would never be enough.

The wall stands not only to recognize the sacrifice of those who died in service to our country, but to let the friends and family of those who served know that their loved one's sacrifice will never be forgotten by the nation they would give their life for. The names on that wall deserve respect, honor, and remembrance. Each of those names deserves someone pausing, and thanking God for the sacrifice that they have made, praying for those who will never forget that name, knowing that to somebody, he isn't just a name on a wall, he was their life, their hope, their will to live.

More Than Names On the Wall

May is the month of Memorial Day, when we remember those who have died in service to our country. Twelve of the 76 young men on our Washtenaw County Vietnam Memorial made the supreme sacrifice during the month of May. They are listed on the front page of this issue. If you read further, you will see that the 12 KIA's listed were buried in 11 different cemeteries. If, over the Memorial Day weekend, you happen to visit any of these cemeteries, perhaps you will remember these brave young men. Check the website (www.vva310.org) for the listing of cemeteries and who is buried in each. It will not identify the location of the grave, however.

The 76 men on the Washtenaw County Vietnam Memorial are buried in 26 different cemeteries around our area, as well as in 8 other states. Washtenong Memorial Park on Whitmore Lake Road in Ann Arbor has the largest number of Vietnam KIA's – 10 buried there. Others include 5 in Highland Cemetery on North River



Road, Ypsilanti, MI; 4 in United Memorial Garden on Curtis Road, Ypsilanti, MI; 4 in Bethlehem Cemetery, Jackson Road, Ann Arbor, MI; 3 in Arbor Crest Memorial Park, Glazier Way, Ann Arbor; 3 in Oak Grove Cemetery, North Freer Road, Chelsea, MI, 2 in Forest Hills Cemetery, Observatory Street, Ann Arbor, MI, 2 in Forest Lawn Cemetery, Dexter, and 2 in Marble Park, West Main Street Milan, MI. There were 3 buried in Arlington National Cemetery in Arlington, Virginia. There were 9 out-of-state burials (Alabama, Florida, Mississippi, New York, North Carolina, Ohio, West Virginia, and Washington State). Closer to home, the following cities are where one service member is laid to rest: Altona, Ann Arbor Greek Orthodox Church, Ann Arbor St. Thomas Church, Benzie County, Clinton, Detroit, Inkster, Kalkaska, Leelanau, Manchester, Milan (London Cemetery), Saline, Sherwood, Tecumseh, Wayne County, Ypsilanti (Union-Udell), Whittaker, and York Township, Michigan. The ashes of David Scott Palmer were laid to rest in Lake Michigan. May they all rest in peace.

The names of the 76 men from Washtenaw County also appear on The Vietnam Veterans Memorial in Washington, DC. The wall honors U. S. service members who fought in the Vietnam War, service members who died in service in Vietnam/Southeast Asia, and those service members who were unaccounted for (Missing In Action) during the war. Completed in 1982, Memorial Wall is made up of two 246 feet 9 inches long gabbro rock walls, etched with the names of the servicemen being honored in panels of horizontal rows. The walls are sunken into the ground, with earth behind them. At the highest tip (the apex where they meet), they are 10.1 feet high and they taper to a height of 8 inches at the extremities. Symbolically, this is



described as a wound that is closed and healing. Each wall has 72 panels, 70 listing names (numbered 1E through 70E and 70W through 1W) and two very small blank panels at the extremities.

The wall originally listed 58,191 names when it was completed. As of May 2016, there are now exactly 58,315 names, including eight women. Approximately 1,200 of these are listed as missing (MIAs, POWs, and others). The names are listed in chronological order, starting at the apex on panel 1E in 1959, moving day by day to the end of the eastern wall at panel 70E, which ended on May 25, 1968, starting again at panel 70W at the end of the western wall, which completes the list for May 25, 1968, and returning to the apex at panel 1W in 1975.

Part of the spreadsheet I am developing lists the panel location of each of the 76 men on the wall in Washington, DC. Pete Belaire has done the hard part of researching the panel location of each of our 76 guys. Their names appear on 57 of the 140 panels of names on the wall. The earliest is George Frederick Vlisides (panel 01E line 084; DOD 01/27/65) and the last is John David Eddy (02W 096; DOD 01/11/72). While Vlisides died almost exactly 7 years before Eddy, they are only 2 panels from each other on the wall. Beyond them are the 74 others from Washtenaw County who died serving in Vietnam (2 still MIA). Panel 05E contains the names of 4 of our young men – Stanley James Thompson, Roger Dean Bulifont, Clark Newell Woodworth, Jr., and Jack Maynard Hopkins. This panel reflects those killed early in the war, February 1966 with 2 being the same day on February 28, 1966). Much more information on The Wall can be found at www.thewall-usa.com.

George Vernon Airey, Jr. was born on July 21, 1944 to Mr. and Mrs. George V. Airey, Sr. of Ann Arbor. George, Jr. is the son of the President of G.V. Airey Building Company. He is a 1962 graduate of Ann Arbor High School, and also studied construction and building at Ferris State University and Lansing Community College prior to enlisting in the Army.

Specialist 4 Airey, Jr. enlisted in the Army in 1966 and received his training at Fort Carson, Colorado. George started his Vietnam tour in November of 1967 as an Armor Reconnaissance Specialist with D Company, First Battalion, Fifth Cavalry Regiment of the First Cavalry



Division. "On the night of 08/09 May 1968, the 1st Battalion, 5th Cavalry, was operating in western Quang Tri Province from a temporary base. At 0705 on 09 May, the Battalion came under attack by North Vietnamese Army forces - initially by mortar fire, then a full-fledged ground attack...Charlie Company was cut off from the other companies and bore the brunt of the attack. The NVA were fended off, but not without cost,..." A total of nineteen men died in this action including Specialist 4 George Vernon Airey, Jr who died of multiple fragmentation wounds. He lived 23 years, 9 months and 18 days.

George Vernon Airey, Jr. is resting now in Forest Hill Cemetery in Ann Arbor. George left behind his parents and two sisters. George was awarded the Purple Heart, National Defense Service Medal, Vietnam Service Medal, Vietnam Campaign Ribbon, Expert Rifleman's Badge and posthumously awarded a second Purple Heart and the Bronze Star. His name is listed under Ann Arbor on the Ypsilanti Township Vietnam Memorial, and on Panel 57E Line 012 on the Vietnam Memorial in Washington, DC.



Private First Class **Roy Lee Branham** was born on March 28, 1949 in Lancer, Kentucky to Mrs. Edra Sester. Roy lived in Ypsilanti for ten years before moving to Dexter where he lived for seven years.

Private First Class Branham entered the Army on September 1, 1966 completing his Basic Training at Fort Knox, Kentucky. He received advanced training at Fort Leonard Wood, Missouri and Fort Gordon, Georgia. Roy began his tour of duty in South Vietnam on April 2, 1967 serving as a Wire Systems Installer with A Company, 1st Battalion, 5th Infantry Regiment, 25th Infantry Division. Private First Class Branham died on May 11, 1967 at the 106th General Hospital in Japan of wounds received in

April. Roy was posthumously awarded the Bronze Star Medal recognizing his meritorious service while participating in combat operations in Vietnam.

Roy Lee Branham is survived by his mother, one brother and a sister. He lived for 18 years, 1 month and 13 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Roy Branham is the youngest person from Washtenaw County killed in Vietnam. He is listed on the Vietnam Memorial in Ypsilanti Township under Dexter. His name also appears on the Vietnam Memorial in Washington, DC on Panel 19E Line 089.

Sergeant Charles Patrick Brown was born on December 27, 1947 in Ann Arbor, Michigan to Mr. and Mrs. Chester A. Brown. Charles graduated from Ann Arbor High School in 1966. His friends called him "Chuckie". He enlisted in the Army in 1965, but delayed entry until June 29, 1966 after his High School graduation. Sergeant Brown completed Basic Training at Fort Knox, Kentucky, Advanced Infantry Training at Fort Ord, California and Paratrooper Training at Fort Benning, Georgia. Charles served a tour of duty in Alaska where his parachute failed to





open during a jump landing him in the hospital for six weeks.

Sergeant Charles Patrick Brown began his tour of duty in Thua Thien Province, South Vietnam on November 5, 1967 serving with C Company, 2nd Battalion, 502nd Infantry, 101st Airborne Division as an infantryman. Charles was wounded twice during combat operations, and recovered from malaria two times. He just returned to his unit in April after being discharged from the hospital when he was killed on May 21, 1968 as a result of multiple fragmentation wounds.

Charles Patrick Brown is survived by his parents and one sister. He lived 20 years, 4 months and 24 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Charles' name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 64E Line 012.



Storekeeper Third Class James Michael Bryan was born on November 2, 1946 in Portsmouth, Ohio to Mr. and Mrs. Wallace R. Bryan. James is a 1964 graduate of Milan High School. He attended Cleary College prior to entering the Navy on December 29, 1965.

Storekeeper Third Class Bryan was stationed at Da Nang, Quang Nam Province, South Vietnam where he served with Supply Operations, Naval Support Activity Da Nang. On May 14, 1967, James was riding in a truck as a passenger returning to base when the truck became involved in an accident. He was thrown from

the truck receiving multiple concussions and died before he arrived at the Base Hospital.

James Michael Bryan is survived by his parents and one brother. He lived 20 years, 6 months and 12 days. James was posthumously awarded the Navy Unit Commendation Ribbon, the National Defense Medal and the Vietnamese Service Medal, and the Republic of Vietnam Campaign Ribbon. The Navy Unit Commendation citation reads, "For exceptionally meritorious service from October 15, 1965 to August 15, 1966, in carrying out the vital and constantly mounting task of unloading, moving and storing supplies to support the expanding tactical forces...despite extremely adverse climatic conditions, shortages of equipment and personnel,...continuous exposure to attack." James Bryan is now resting in Memorial Burial Park in East Portsmouth, Ohio. James' name is listed on the Vietnam Memorial located in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 19E Line 115.





Private First Class **Paul Dean Elwart** was born on June 14, 1946 to Mr. and Mrs. David G. Elwart of Ypsilanti, Michigan. Paul is a 1964 Honor graduate of Sacred Heart High School in Detroit, Michigan. He also attended the

University of Michigan, Michigan State University and the University of Detroit before entering the Army in September of 1968.

Private First Class Elwart began his tour of duty in Tay Ninh Province, South Vietnam on February 9, 1969 as an infantryman serving with C Company, 1st Battalion, 7th Calvary, 1st Calvary Division. Paul was killed on May 12,

1969 due to multiple fragmentation wounds just three months and three days into his tour of duty "In-Country".

Paul Dean Elwart is survived by his parents and a brother. He lived 22 years, 10 months and 26 days. Paul's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 25W Line 067.

Specialist 4 **Billy Ferrell** was born on February 27, 1951 in Prestonburg, Kentucky to Mr. and Mrs. Hobert Ferrell of Ypsilanti, Michigan. Billy attended Ypsilanti High School prior to enlisting in the Army on January 27, 1969.

Specialist 4 Ferrell completed his Basic Training at Fort Knox, Kentucky, and then attended Parachutist School at Fort Bragg, North Carolina. Billy began his tour of duty in Binh Dinh Province, South Vietnam on November 24, 1969 serving as a rifleman with B Company, 1st Battalion, 503rd Infantry, 173rd Airborne Brigade. He was killed as a result of a severe gunshot wound to his chest on May 29, 1970.



Billy Ferrell is survived by his parents, three brothers and eight sisters. He lived 19 years, 3 months and 2 days. He is resting in Highland Cemetery in Ypsilanti, Michigan. Billy's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 10W Line 117.



Specialist 5 **Robert Lee Freeman** was born on April 2, 1948 in Harlan, Kentucky to Mr. and Mrs. Olin Gilbert. Robert is a 1966 graduate of Willow Run High School in Ypsilanti, Michigan. He also attended Michigan State University in Lansing, Michigan.

Specialist 5 Freeman entered the Army in April of 1967. Robert began his tour of duty in Long Khanh Province, South Vietnam on April 9, 1969 serving as a Cannon Fire Direction Specialist with Headquarters, Headquarters Battery, 2nd Battalion, 35th Artillery, 54th Artillery Group, II Field Force. Robert was killed as a result of



enemy heavy arms fire on May 18, 1969 after serving "In-Country" for one month and nine days.

Robert Lee Freeman is survived by his parents and a sister. He lived 21 years, 1 month and 16 days. He is resting in Knollwood Memorial Park in Wayne County, Michigan. Robert's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 24W Line 040.



Specialist 4 James Wilson Harter was born on May 16, 1947 to Mr. Henry W. and Mrs. Helen G. Carey Harter of Dexter, Michigan. James is a 1967 graduate of Dexter High School in Dexter, Michigan. He entered the Army on February 13, 1968 completing his Basic Training at Fort Knox, Kentucky. He completed advanced training as a combat engineer at Fort Leonard Wood, Missouri on June 14, 1968.

Specialist 4 Harter began his tour of duty in Binh Long Province, South Vietnam on July 13, 1968 as a Combat Engineer serving with B Company, 31st Engineering Battalion, 79th Engineering Group, 20th Engineering

Brigade. James was killed during a fire-fight with two enemy platoons on May 12, 1969. According to an Ann Arbor News article, "he was awarded the Army Commendation Medal for Heroism for "exceptionally valorous actions on May 12 while serving as a perimeter guard at Quang Loi Base Camp. Two enemy platoons launched a ground assault on the camp, ...he engaged the enemy with a heavy and accurate volume of automatic weapons fire...stalling the enemy and giving his comrades time to reinforce the perimeter line...despite his valiant efforts...an enemy round detonated inside his position instantly killing him." James Wilson Harter is survived by his parents, two sisters and a brother. Two of his brothers preceded him in death in 1961 and 1968. He lived 21 years, 11 months and 26 days. He is resting in Forest Lawn Cemetery in Dexter, Michigan. James' name is listed on the Vietnam Memorial in Ypsilanti

Township under Dexter. His name also appears on the Vietnam Memorial in Washington, DC on Panel 25W Line 070.

Corporal **Russell Arthur Michalke** was born on July 24, 1948 to Mr. and Mrs. Art Michalke of Saline, Michigan. Russell graduated from Saline High School in 1966 where he lettered in varsity football for two years, and lettered in baseball and golf for one year. He belonged to the "S" Club for two years, Spanish Club, Chorus, and





the Key Club. Russell attended Washtenaw Community College for a year prior to entering the Army on August 8, 1967. He completed his Basic Training at Fort Knox, Kentucky with further training at Fort Edwards, Louisiana.

Corporal Michalke began his tour of duty in Chu Lai, Quang Tin Province, South Vietnam on January 20, 1968 serving as an infantryman with A Company, 1st Battalion, 6th Infantry, 198th Infantry Brigade, Americal Division. Russell was killed on May 24, 1968 as a result of enemy small arms fire.

Russell Arthur Michalke is survived by his parents and two sisters. He lived 19 years and 10 months. He is resting in Oakwood Cemetery in Saline, Michigan. Russell's name is listed on the Vietnam Memorial in Ypsilanti Township under Saline. His name also appears on the Vietnam Memorial in Washington, DC on Panel 68E Line 005.



Sergeant Charles Irvin Miller was born on March 2, 1946 in Grand Rapids, Michigan to Mr. and Mrs. Robert V. Miller of Ann Arbor, Michigan. Charles is a 1964 graduate of Ann Arbor High School. He attended the University of Michigan and Eastern Michigan University before enlisting in the Army in March of 1966. He received his Basic Training at Fort Knox, Kentucky, and Advanced Training at Fort Hood, Texas.

Sergeant Miller began his tour in Quang Nam Province, South Vietnam on October 6, 1967 serving as a Military Policeman with MP Platoon Headquarters, Headquarters Company, 198th Infantry Brigade, Americal Division.

Charles was killed by an explosive device on May 13, 1968. He was posthumously promoted to Sergeant and awarded the Bronze Star Medal, Good Conduct Medal, and Purple Heart. According to the Bronze Star Medal Citation, "He was quick to grasp the implications of new problems with which he was faced as a result of the ever changing situations inherent in a counterinsurgency operation. His initiative, zeal, sound judgment and devotion to duty have been in the highest tradition of the U.S. Army."

Charles Irvin Miller is survived by his parents and two sisters. He lived 22 years, 2 months and 11 days. He is resting in Bethlehem Cemetery in Ann Arbor, Michigan. Charles' name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 59E Line 029.

Corporal **Alan Hugh Parks** was born on November 13, 1948 to Mr. and Mrs. Max Parks of Bronson, Michigan. Alan graduated from Union City High School in 1966 and was a member of the 1965 - 1966 State Champion Debate Team. In 1965, Alan represented Union City High School at Wolverine Boys State. His skills in debating won him further honors. In August of 1966, Alan won first place in the 4-H state public speaking contest, and he later won state





honors as a champion debater at Kellogg Community College, which he attended for two years. Alan Parks also was elected to the office of student vice-president of the Phi Rho Pi Honor Society and the National Organization of Junior College Debating and Forensics in 1967 - 1968. Alan worked for the Shell Oil Company before entering military service.

Corporal Alan Hugh Parks entered the Army on August 21, 1969. Alan was trained as an Armor Reconnaissance Specialist and served with A Troop, First Squadron, First Cavalry, Americal Division in Vietnam beginning his tour on January 11, 1970. Corporal Parks was stationed at Chu Lai and died as a result of burns when the vehicle he

was driving was hit by enemy fire on May 27, 1970 in Quang Tin Province, South Vietnam.

Corporal Alan Hugh Parks is survived by his parents, wife, daughter, sister, and three brothers. He lived 21 years, 6 months and 14 days. Alan is resting in Sherwood Cemetery in Union City, Michigan. Alan Hugh Parks' name is listed under Manchester on the Vietnam Memorial located in Ypsilanti Township, and on the Vietnam Memorial in Washington, DC on Panel 10W Line 110.

Sergeant **Peter Lyle Valencich** was born on January 1, 1947 in Ann Arbor, Michigan to Mr. Joseph and Mrs. Naomi Gidley Valencich of Manchester, Michigan. Peter is a 1965 graduate of Manchester High School where he was a member of the Varsity Basketball Team. He was employed with the Double A Product Company in Manchester before entering the Army on May 16, 1966. He went through Basic Training at Fort Reily, Kansas, and was awarded the medal for the highest scorer on the Army's Proficiency Test while in Basic.



Sergeant Valencich began his tour of duty near Tan Tru, South Vietnam on December 1, 1966 serving as an

infantryman with A Company, 2nd Battalion, 60th Infantry, 9th Infantry Division. Peter was awarded the Bronze Star Medal for heroism in action having carried a helpless wounded comrade 75 meters to safety from an unprotected open area. He was killed on May 22, 1967 when he was helping to clear a mangrove by burning reeds when the fire set off a friendly mine.

Peter Lyle Valencich is survived by parents, a brother, and four sisters. He lived 20 years, 4 months and 21 days. He is resting in the Oak Grove Cemetery in Manchester, Michigan. Peter's name is listed on the Vietnam Memorial in Ypsilanti Township under Manchester. His name also appears on the Vietnam Memorial in Washington, DC on Panel 20E Line 088.


