


# President's Message:



### More Than Names On the Wall

Part Five, by Jane Kinzinger

I think of August as the month of reflection. Summer is quickly slipping away. What have I done to make the most of summertime. What were the milestones? What have I accomplished? This leads me to this month's focus on the awards and medals earned by the 76 young men listed on our Memorial. Unfortunately, the information available on each of the 76 young men on the Washtenaw County Vietnam Veterans Memorial is not complete. Awards might have been overlooked or not reported by their family.

The Purple Heart is awarded in the name of the President of the United



our Memorial received the Purple Heart posthumously. One (Airey) has two Purple Hearts and a Bronze Star, and one (C. Brown) has three Purple Hearts plus a Bronze Star. These young men answered their country's call. They made the supreme sacrifice. They were all outstanding men.

Heroic actions lead to LTC Charles S. Kettles' being awarded the Medal of Honor, which is the highest military decoration of the United States. It is awarded for "gallantry and intrepidity at risk of life above and beyond the call of duty." The Distinguished Service Cross is the second highest military award that can be given to a member of the United States Army (and previously the United States Air Forces and the United States Air Force) for extreme gallantry and risk of life in actual combat with an armed enemy force. Actions that merit the Distinguished Service Cross must be of such high degree that they are above those required for all other U. S. combat decorations but do not meet the criteria for Medal of Honor. The Distinguished Service Cross is equivalent to the Navy Cross (Navy and Marine Corps), the Air Force

Cross (Air Force) and the Coast Guard Cross (Coast Guard) (The Institute of Heraldry). In 1968, then Major Charles Kettles received the Distinguished Service Cross for his gallant actions of July 17, 1967. On 18 July 2016, his DSC was upgraded to the Medal of Honor.





The Distinguished Flying Cross was awarded to three men on our Memorial - Adams. Vlisides, and Wagener, who distinguished themselves in support of operations by "heroism or extraordinary achievement while participating in an aerial flight" (DOD Manual 1348.33-V3).



The Silver Star is the United States military's third highest personal decoration for valor in combat. Valor – great courage in the face of danger, especially in battle – bravery, courage, fearlessness, boldness, heroism. The Silver Star Medal is awarded primarily to members of the Armed Forces for valor and gallantry in action against an enemy of the United States while engaged in military operations involving conflict with an opposing foreign force. Among the 76 young men killed in Vietnam from Washtenaw County, there were seven Silver Stars awarded: Arvin (2), Boss, Ferrell, Gougar,

Jordan and Maki. This shows the character and dedication of these men.

The Bronze Star is the fourth highest award for military combat



The Bronze Star is the fourth highest award for military combat bravery is awarded to any person whom while serving in any way in or with the United States military after 6 December 1941, that distinguished himself or herself apart from his or her comrades by brave or praiseworthy achievement or service, that did not include participation in aerial flight. The act justifying award of the Bronze Star medal must be performed while fighting an enemy of the United States, or while involved in conflict with an opposing/foreign force.

Heroism carried out under acts as described, which are of a lesser degree than those awarded of Silver Star, will justify the award of the Bronze Star. The Bronze Star was awarded to 21 of the young men on our Memorial: Airey, Atkins, Bird, Boss, Bousley (2), Branham, Brown, Eddy, Ferrell, Fulton, Gougar, Gray, Hoag, Jordan, Maki, Miller, Shambough, Suarez, Valencich, Vlisides, and Warren. The Bronze Star with "V" was awarded to Billy Ferrell, along with a Silver Star for Gallantry.

Other awards mentioned in the 76 write-ups include: Air Medal, Good Conduct Medal, Combat Infantryman Badge, Marksman Badge with the Automatic Bar, Parachute Badge, South Vietnam Government Military Merit Medal + Gallantry Cross with Palm, Army Commendation Medal for Heroism, Navy Commendation Medal, and South Vietnam Government's Armed Services Expeditionary Medal. ### AUGUST'S KIA'S - MAY WE NEVER FORGET

Private First Class James William Davis was born on March 24, 1947 in Erie, Pennsylvania to Mr. and Mrs. William A. and Gretchen Raub Davis. James grew up in Belleville, Michigan, but lived in Ypsilanti. He is a 1965 graduate of Belleville High School where he lettered in football and swimming. James attended Michigan State University and Cleary College. James was employed as a customer agent for Trans World Airlines at the Detroit Metropolitan Airport in Wayne, Michigan prior to his to entering the Marine Corps on December 13, 1968.

Private First Class Davis began his tour of duty in An Hoa, Quang Nam Province, South Vietnam on July 7, 1969 serving as a rifleman with I Company, 3rd

Battalion, 5th Marines, 1st Marine Division. James was killed on August 13, 1969 as a result of small arms fire just one month and six days into his tour of duty "In-Country".

James William Davis is survived by his wife, an 11 month old son, his parents, and two brothers. He lived 22 years, 4 months and 10 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. James' name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 19W Line 029.

Lance Corporal **Kendal Lee Benney, Jr.** was born on February 22, 1948 to Mr. and Mrs.Kendal L. Benney of Ypsilanti. Kendal lived with his father and step-mother in Big Rapids, Michigan until September of 1965 where he attended Ypsilanti High School. He left Ypsilanti High School during his Junior year and enlisted in the Marine Corps in March of 1966.

Lance Corporal Kendal Lee Benney, Jr. began his tour of duty in Quang Nam Province, South Vietnam in December of 1966 serving with C Company, First Battalion, Seventh Marines, First Marine Division as a machine gunner. Kendal was killed on August 20, 1967

while standing watch when he suffered multiple fragmentation wounds from a bomb.

Lance Corporal Kendal Lee Benney, Jr. is survived by his mother, father, step-mother, two sisters and one brother who was serving in South Vietnam when his brother was killed. Kendal's brother was discharged from the Army and escorted his brother back to the "World" for internment. Kendal lived 19



years, 5 months and 28 days. He is resting in the Altona Cemetery in Altona, Michigan. Kendal's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 25E Line 018.

# Regular Meeting Minutes

13 Jul 2017

Meeting called to order by President Dave Draper at 1903

Pledge of Allegiance and moment of silence for POW/MIA's, their families, and for those serving in hazardous places around the world.



**Roll call**: A quorum was established. Welcome Home Everyone. Guests: None

**Motion** made by Dave Draper to approve the 8 Jun 2017 general meeting minutes as printed in the Dispatch. Seconded by Tim Driscoll. Motion unanimously approved.

### President's Report:

If any member desires to purchase a VVA 310 shirt, simply email Dave Draper with your name as desired on the shirt and size. Cost will be approximately \$30.00. Dave will follow up with Tom Mullins as to when payment will be required.

Next month Jon Luker, Secretary, and I will be attending the VVA National Convention in New Orleans. Al Merritt, Vice President, will officiate at the 10 Aug 2017 general meeting.

On July 4th the parade was well attended and the Veterans' Picnic which followed was well received and attended. A special note of thanks to Jon Luker and Al Merritt for organizing the picnic.

Merchandise sales under the direction of Vance McCrumb was held on Tuesday, 11 Jul 2017 at the VA Medical Center (VAMC). Total sales were around \$950.00 and \$190.00 or 20 per cent of that was remitted to the VAMC Canteen office. A special thanks to all those that assisted Vance in this effort. We need a volunteer to direct this sale next month.

Dave distributed get well cards for Eddy Conrad and Bruce Ross, two members who are recovering from recent illnesses.

### Treasurer's Report:

Paulo Pereira, Treasurer, presented and explained a Statement of Assets, Liabilities, and Fund Balances. There were several questions about the activity, receipts and expenses, in the Food Pantry and Memorial Maintenance funds. With only \$13,553 in the operating cash account how would we fund



the \$26,093 total in the designated funds if we had to close those funds. It was mentioned that we would simply liquidate the Certificate of Deposit – Non -Building.

There was considerable discussion on the merchandise inventory and when should a physical inventory be performed. Special thanks to Meni Draper for completing a physical inventory of everything except the pins as of 11 July 2017 to give us a starting point going forward. Dave Draper said he hoped the pins would be inventoried within the next couple of weeks. Paulo mentioned that we are working on a new procedure to properly control these assets. The group consensus was that a physical inventory as of fiscal year end should be performed to properly report this activity in our annual reports to National, State and the IRS.

### **AVVA Report:**

Kathy Driscoll gave her report and stated that \$715 was raised in May at the Quartermania. She also stated that numerous contributions were made as follows: \$100 to AVVA Project Friendship in New Orleans; \$100 to Sons and Daughters in Touch; \$100 to Vietnam Memorial Education Fund; and \$1,000 to Fisher House Michigan. She also mentioned that the AVVA has fund-raised a total of \$3,500 so far for Fisher House Michigan. Kathy also noted that the new AVVA tree at the Vietnam Veterans Memorial will hopefully be dedicated sometime in September.

### Committee Reports:

Food Pantry – Don Miller stated there was no activity

**Merchandise** – Vance McCrumb previously reported on the recent sales at the VAAAHS. Dave Draper requested a volunteer to coordinate the 8 Aug 2017 sales effort at the VAAAHS.

WCCV - No report

Memorial - No report

**Website** – Vance McCrumb stated that everything is operating as required. Dave Draper stated that he has had our web hosts re-install the Donate button and would like to see the DONATE button more prominently displayed on the website. Possible on the first page when the website is opened.

Membership - Vance McCrumb reported 196 members on the roster.

**Newsletter** – Dave Draper requested that any articles for the website are needed, as only a few people are participating.

**VAMC** – John Kinzinger stated that the Halloween Party at the VAMC is scheduled for Saturday, Oct. 28, 2017. He will report next month as to dates of the two Christmas events.

### Old Business:

**Fisher House** – The new Fisher House in Ann Arbor, MI is required to provide military families housing close to a loved one during hospitalization at the Ann Arbor VA Medical Center, which is the largest VAMC in the state.



Elmer White stated that a Contribution Campaign needs to be developed to contact every VVA Chapter from Ann Arbor to the Mackinac Bridge. \$300,000 Capital is required. Sandie Wilson announced that \$27,000 was donated to the Fisher House from the sale of the veterans home she managed.

**Townhall for Veterans** – At 1730 hours on Monday 24 Jul 2017 a Townhall for Veterans will be held at Washtenaw Community College. Political representatives U.S. Senators Gary Peters and Debbie Stabenow and U.S. Congress representatives Debbie Dingell and Tim Walberg are expected to be in attendance.

Chapter Telephone Number – Paulo stated that the current chapter phone as listed is no longer working. There was discussion as to why we need a phone number. A vote was taken whether we should re-establish a phone number and the overwhelming majority of members present voted not to continue with phone service. An existing Contact Us button on the Chapter's website allows those individuals to contact us via email.

### **New Business:**

Don Miller stated that he is passing around volunteer sign-up sheets for the Heritage Festival on Aug. 26, 27, and 28 and the Pig Roast on September 10th.

Sandy Wilson stated that she has done extensive work on PTS and PTSD issues. She has learned that the Ann Arbor VA claims that PTS has been cured in certain cases by approximately thirteen visits to a VA Center. However, PTSD can't be cured because it damages the white matter in brain which is irreversible. Sandy's point is that if you get involved with any veterans concerning PTSD make sure you seek professional consulting. It has been reported that certain VA doctors have overprescribed medication which has resulted in additional medical problems.

### Good of the Chapter:

AVVA member, Marty Cothorn, has been appointed as a Representative to the Nursing Board at the Ann Arbor VAMC. Please feel free to contact her if you have any questions on concerns about a Veteran's treatment plan.

Several of the departments of the VAMC will be moving offsite in the upcoming months. Those include Comp & Pension and Audio going to 3800 Packard, and Dermatology and Sleep Clinic to 2500 Green Road.

<u>Next Meeting:</u> 1900 hours on Thursday, Aug 10th for general membership which follows the Board of Directors meeting at 1800 hours.

<u>Next Chapter Breakfast:</u> 0900 hours on Friday, July 14th, at Bomber Restaurant in Ypsilanti.

<u>Closing Prayer:</u> John Kinzinger gave the closing prayer.

Meeting Adjourned: President Draper adjourned the meeting at 2022 hours.

Camp Lejeune Exposure 8/1/1953 to 12/31/1987. Reference 38 CFR 3.307 & 3.309(f) The following are areas of exposure that are considered within Camp Lejeune:

Air Station New River, Camp Geiger, Camp Johnson, Naval Hospital Camp Lejeune, Tarawa Terrace, Camp Knox, Montford Point, Stone Bay Rifle Range, Holcomb Boulevard, Hadnot Point. MCAS Cherry Point is **NOT** included in Camp Lejeune exposure.

Presumptive conditions for Camp Lejeune exposure are: Adult Leukemia, Aplastic and other myelodysplastic syndromes, Bladder Cancer, Kidney Cancer, Liver Cancer, Multiple Myeloma, Hon-Hodgkin's lymphoma and Parkinson's Disease.
