## More Than Names On the Wall

As we think about back-to-school, we know there are students returning with determination for success, heightened expectations for the ensuing school year, and specific goals in scholastic and athletic endeavors. Many of the 76 young men on our Vietnam Memorial distinguished themselves in their high school years before joining the military and being sent to Vietnam. They excelled in the classroom and on the field. Though information is not complete, here are examples of their leadership and talents.

Three were Senior Class President (Arvin, Fulton and Kushmaul). Kushmaul was also President of Future Farmers of America. Fulton was also named Lincoln High School Outstanding Scholar. Arvin was Class President, Valedictorian and Student Council President. Several were members of Student Council. Parks was Vice President of Honor Society, while four were members of Honor Society, receiving Honors in Math and Science. McIntire was Vice President of a Junior Achievement Company.

In athletics, McKenzie was Captain of St. Thomas High School Football Team and member of the All City and All Southwest Football Team. Lamey was Co-Captain and MVP of Milan Football Team Senior Year. Palmer was Co-Captain of the Ypsilanti Roosevelt High School Swim Team. Spencer was on the 1963 State Champion Ypsilanti Football Team. Scott Smith held a long-standing record (1:59.2) at Chelsea High School for the ½ Mile. Arvin was the 1961 State Wrestling Champion. Many held Varsity Letters in several different sports (basketball, football, baseball, track, golf, and tennis).

Several were recognized for excellence outside of school. Crane was named Newsboy of the Year several times. Spencer attended Wolverine Boys State, and Arvin was an Eagle Scout. Some were recognized for 4H accomplishments. First place for 4H State Public Speaking Contest went to Parks. Kushmaul was awarded Top Showman at Chelsea Fair. A Sweepstake Showmanship Contest for Top Showman at the Chelsea 4H Fair has been awarded each year since his death.

Beyond high school, there were other distinctions. Parks received State Honors as Champion Debater at Kellogg Community College. Boss was a winner at the Milan Dragway. Kirby pursued and received his GED while in the service. Valencich was awarded a Medal for Highest Score on the Army Proficiency Test.

These young men leave other legacies, including the fact that Albertson was the first child born in the community on January 1, 1947. Two young men had nephews named after them.

There were undoubtedly many other areas of excellence and proficiency that were not recorded or mentioned. And, perhaps some were happy just to achieve a passing grade in a class or have enough credits to graduate. Whether outstanding or not, they are all heroes and earn our highest honor for their service and great sacrifice. By Bill Vollano

I remember how relieved I was in high school when I found out I could take Government, instead of U.S. History, to satisfy graduation requirements. Obviously, I avoided history courses as much as possible. And, in college there was not a hard-and-fast requirement to take any history courses. It wasn't until I talked to my uncle who had landed in Normandy that I got a sense of why it was so difficult and, at the same time, important that Veterans share their stories.

I had four uncles and a cousin who saw combat in WW II. Two uncles received wounds that qualified them for 100% disability. At the 50th anniversary of D-Day, I asked my uncle if he planned to go to France to celebrate D-Day. He said, "There is nothing about that experience that I want to remember."

Why did I get involved with the Veteran's History Project? To make sure that Veterans are encouraged to tell their stories. Now I know that not all Veterans have "exciting" stories to tell, but they are all important. I served two years in the Army in the late 1950s in San Antonio, Texas, at Brooke Army Hospital. I have captured my story.

As the Assistant Historian for VVA 310, I've been fortunate to interview about a dozen Chapter 310 members. With a Chapter membership of more than 190, that's not even ten percent. Many of you feel that you did nothing important during your time in the military. If you served, you have a story that needs to be told, for your children and grandchildren, friends, and, my grandchildren.

### Forever GI Bill Now Law of the Land

(Washington, DC) - "Today military, veterans, and family service organizations have made history -- by having willed the *Forever GI Bill* into law," said John Rowan, President of Vietnam Veterans of America. "We are incredibly grateful for this unity, and an opportunity to leave future veterans with better benefits than we, ourselves, were afforded as we transitioned from service. As a community, we have changed the conversation on the GI Bill, from being a 'cost -of-war,' to being a part of every veteran's successful transition."

"Today, and in the future, service members are not choosing when they go to war, so the government shouldn't be able to tell veterans when they can use the GI Bill that they earned through service," continued Rowan. "Thank you to Congress, for your unanimous support of the *Forever GI Bill*, and to all of the advocates who have stood with us in fighting for the *Forever GI Bill*.

# **Appeals Modernization Bill Falls Short**

(Washington, DC)–On August 23, 2017, President Trump signed into law the Veterans Appeals Improvement and Modernization Act of 2017, a bill which dramatically overhauls the claims and appeals process for veterans seeking disability compensation benefits to which they are entitled.

"While the Veterans Appeals Improvement and Modernization Act of 2017 is touted as a means for veterans to receive 'faster and more efficient decisions,' we fear this new law limits due process protections and fails to address-much less fix-the fundamental problems with the broken claims system, the need for binding legal precedent," said John Rowan, VVA National President.

"Under this new law, without a precedent-setting mechanism that actually works, veterans who have nearly identical records will continue to receive drastically different decisions, and the never-ending churn of cases between all levels of appeal will go on and on," noted Rowan.

"Making a claims system more efficient at the expense of veterans is not justice for veterans. We know the job to fix the broken appeals system is far from over. Vietnam Veterans of America remains committed to working with the best legal minds in America--in Congress and elsewhere--to develop legislation that would establish an appeals system that works to address, first and foremost, the needs of veterans and not just the needs of VA," continued Rowan.

"America's veterans deserve a claims system that is just, consistent, and efficient. In the short term, it is up to VVA and our fellow veterans' service organizations and stakeholders to ensure that the regulations promulgated to implement this law are consistent with a pro-veteran and non-adversarial claims system. We are confident that our colleagues will join in this effort to make the regulations as fair as possible, within the limits of this new statute," said Rowan.

## From A Letter Sent Home

#### By John Kinzinger

Not long before I wrote the subject letter, I was operating my FM radio relay at a Landing Zone back to battalion. A patrol had been sent out to scout the immediate area. Not long after leaving the LZ the patrol was ambushed by a young VC with an automatic weapon. The patrol returned fire stopping the enemy fire. The shooter was a child of 13 or 14 who was brought back to the LZ. Two medics worked to try to save him until we could get a medivac chopper to come out and pick him up. I do not know if he made it or not. But, I was somewhat bewildered by all that. He was a young boy, but also our enemy.

From my letter of May 23, 1966, to my parents I wrote the following:

"The other day I was in the village near our battalion base camp. I'm ashamed to admit. I came to a great conclusion. That is that the majority of the ordinary people, can't stand us being over here for some reason and don't actually appreciate what we are doing. As long as we are buying from them fine. Putting food in their mouths and money in their pockets is as far as we rate! I mean they would rather have us than the VC's but not by a whole lot. I do not know what Americans have to do to really win people to them. But look at all appreciation we got from the the countries we've helped like France, England and so forth down the line."

"Now, I said 'the better majority of the (This illustration is not his actual letter home.) average people.' They don't have much for

intelligence. For instance, when I first got here, I went out on relay to this ARVN compound. Near where we were set up, an ARVN stepped on something and cut his foot, so one of his buddies grabbed a rock and started pounding the cut and they actually thought it was helping it. Since then, I've seen a lot of things similar to that, people packing cuts with tobacco from a cigarette and such. Not too long ago a Cholera epidemic hit Phan Thiet (the village near our battalion base camp) and 40 people died in about 4 or 5 days before a U.S. medical team could stop it. A lot of things like that make me realize how great it is to be lucky enough to be an American. I believe this year over here will sure mean a lot more to me than I'll ever know."

I just wanted to share those words when I was 20 years old from that fifty year old letter and my thoughts then. I would think most Vietnam Veterans experienced similar. That year over there did have quite an impact on my life, as I know it did with others who served there. John K

Hospital Corpsman Third Class **Gary Robert Shepperdson** was born on July 13, 1946 to Mr. John and Mrs. Margaret Shepperdson of Ann Arbor, Michigan. Gary is a 1965 graduate of St. Thomas High School in Ann Arbor. He also attended Eastern Michigan University before enlisting in the Navy in September of 1966.

Hospital Corpsman Third Class Shepperdson began his tour of duty in Quang Nam Province, South Vietnam on July 10, 1968 serving as a Hospital Corpsman with



Headquarters and Service Company, 2nd Battalion, III Marine Amphibious Forces. Gary was killed on September 30, 1968 as a result of a gunshot wound from enemy rifle fire while participating in Operation Mameluke Thrust. Gary Robert Shepperdson is survived by his mother, a sister and three brothers. His father preceded him in death in 1957. He lived 22 years, 3 months and 17 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Gary's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 42W Line 050.



Lance Corporal Hermon Eugene Fuller, Jr. was born on March 9, 1947 in Ypsilanti, Michigan, to Mr. Hermon E. and Mrs. Eugenia Fuller of Ypsilanti. Hermon is a 1965 graduate of Ypsilanti High School where he ran cross country and played football. He gained a nickname in High School of "Flea" because there was a flea on the Soupy Sales Show named Herman. He also was a member of the Boy Scouts, and he worked on the stage crew for High School plays. Lance Corporal Fuller enlisted in the Marine Corps on July 27, 1965 and received his infantry training at Camp Pendleton, California. Hermon was stationed in Okinawa before being deployed to Quang Tri Province, South Vietnam serving as a rifleman with G Company, 2nd Battalion, 7th Marines, 1st Marine Division, III Marine Amphibious Forces. He died on September 25, 1966 as a result of multiple fragmentation wounds from a mortar attack.

Hermon Eugene Fuller, Jr. is survived by his parents, a brother and three sisters. He lived 19 years, 6 months and 16 days. Hermon's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 11E Line 014.



Hospital Corpsman Third Class **Scott Philip Smith** was born on May 30, 1947 in Ann Arbor to Mr. Philip H. of Grass Lake, Michigan and Mrs. Ralph (Jeane) Foreman, Jr. of Northville, Michigan. Scott is a 1965 graduate of Chelsea High School where he was on the track team and the High School Band. He also attended Grand Valley Junior College in Grand Rapids, Michigan before he entered the Navy on March 17, 1967.

Hospital Corpsman Third Class Smith began his tour of duty in Quang Tri Province, South Vietnam on June 3, 1969 serving as a Corpsman with Headquarters and Service Company, 3rd Battalion, III Marine

Amphibious Forces. Scott was killed on September 17, 1969 as a result of an explosive device.

Scott Phillip Smith is survived by his parents, a half-brother and a half-sister. He lived 22 years, 3 months and 17 days. Scott's name is listed on the Vietnam Memorial in Ypsilanti Township under Chelsea. His name also appears on the Vietnam Memorial in Washington, DC on Panel 18W Line 106.

Meeting called to order by Vice-President Al Merritt at 1903 hours.

<u>glmoore@umich.edu</u> I have been observing the world's situations with great interest. In this observational mode I have heard a few times the phrase: "The world is going nuts!" We have set aside our civility and replaced it with our accentuated differences, as if there was no longer a need for reason. People claim that whatever side they represent, that side has the answers to life's problems, yet, when tested with a truth standard, many of their solutions line up with falsity...not supported by the truth. When the application to those solutions are tested, they come up short.

I thoroughly enjoyed the rigorous course of study for my major in seminary: Systematic Theology. It taught me how to test for truth and how to compare Scripture with Scripture so that I would not be guilty of presuppositional interpretation, a.k.a., reading into Scripture what we want it to say. That process puts us in danger of God's judgement by adding to or taking away from what God intended.

*Weltanschauung*, or its English usage today, World View, means a way a person looks at the phenomenon of life as a whole. Some people (particularly those who have not lived very long) have not formed any broad (inclusive, even "sophisticated") view of life. Younger people are more easily swayed without this "view." And yet, I hear many people talking like young people, easily swayed by the world phenomenon swirling about these days. This results in a lack of reason, or as some have labeled it, "utter madness."

It takes listening to what people say to determine their world view or lack thereof. As Jesus said in Matthew 24:37; "As it was in the days of Noah, so it will be at the coming of the Son of Man [Jesus' return to establish God's Kingdom on earth]."

So, the logical question is, "how was it in the days of Noah?" Genesis 6:5, "Then the Lord saw that the wickedness of man was great on the earth, and the very intent of the thoughts of his heart was only evil continually." Or, as Christ said in Luke 6:45, "A good man brings good things out of the good stored up in his heart, and an evil man brings evil things out of the evil stored up in his heart. For the mouth speaks what the heart is full of."

Let those who claim godliness observe the world scenes and instead of taking a conservative or moderate or liberal side, take a side for truth. It is far more important to be on the side of truth than the side of popularity, especially if that popularity is irrational and evil.

Let us promote truth and love at a time where both seem lacking.
